Schoolwide Program

Briefly describe the school’s plan for effectively meeting the ESSA requirements in alignment with the Local Control and Accountability Plan and other federal, state, and local programs.

Paso Robles Homeschool has evaluated data around student performance to drive our plan to ensure students have the ability to improve performance. Reviewing the California Dashboard and site data, our needs assessment revealed improvement needed in the area of Chronic Absenteeism. This targeted area aligns with our district LCAP goals.

## Surveys

Parent input is gathered through surveys and engagement at parent get-togethers, School Site Council, and Parent Advisory Council meetings. Parents provided specific feedback through 2 surveys (District LCAP and parent survey). These surveys reveal that families feel knowledgeable and confident in their ability to support and ensure their child's learning needs are met, that they expressed agreement with their sense of warmth, inclusion and cultural responsiveness of our school, that families feel respected, valued and treated as equal partners by school staff and that they were comfortable talking to the principal, the principal was responsive to concerns, the principal used parent feedback and provided opportunities for parents/families to be equal partners

Given the small nature of home school, teachers were solicited for feedback directly throughout the year. All staff believed that we hold high standards for all students and that there is a strong sense of responsibility for student success, but that family engagement and attendance was crucial for success at school.

## Classroom Observations

Due to the size of the school, classroom observations occur on a near daily basis. Consistent evidence of clear expectations and goals embedded within the lesson objective. Observations demonstrate teachers formed a tight-knit and collaborative team and work well with parents to craft learning that is aligned with standards and clearly present achievable tasks for students and families.

## Standards, Assessment, and Accountability

Use of state and local assessments to modify instruction and improve student achievement (ESEA)

Homeschool uses state assessments, Measure of Assessment and Performance tests, progress monitoring tools, curriculum based assessments, and other assessments to inform instruction. Classroom teachers deliver core instruction and differentiate instruction for students of all performance abilities. Teachers collaborate to plan and organize curriculum to support these multiple performance levels. Progress monitoring occurs weekly and is regularly reviewed for continued support.

Use of data to monitor student progress on curriculum-embedded assessments and modify instruction (EPC)

Due to the size of the school, all staff meets daily to review student performance and to modify instruction based on performance. Process is monitored by administration and supported by SPED, psychologist, mental health therapist, and counselor teams.

## Staffing and Professional Development

All Homeschool teachers are highly qualified.

All teachers have been fully trained through state, district and ongoing site based professional development.

Alignment of staff development to content standards, assessed student performance, and professional needs (ESEA)

Staff development is planned to ensure classroom instruction is aligned with student performance needs and utilizes best practices.

Ongoing instructional assistance and support for teachers (e.g., use of content experts and instructional coaches) (EPC)

Administration supports teachers through daily check-ins and instructional monitoring.

Teacher collaboration by grade level (kindergarten through grade eight [K–8]) and department (grades nine through twelve) (EPC)

Our two teachers collaborate daily.

## Teaching and Learning

Alignment of curriculum, instruction, and materials to content and performance standards (ESEA)

Home school uses district adopted and approved curricula. Supplemental programs such as are used to support students and accelerate learning. Grade level pacing plans have been established by the district Curriculum Committee comprised of teachers and district personnel.

Adherence to recommended instructional minutes for reading/language arts and mathematics (K–8) (EPC)

Home school is in compliance with necessary independent study models for recommended instructional minutes.

Lesson pacing schedule (K–8) and master schedule flexibility for sufficient numbers of intervention courses (EPC)

Pacing is determined on an individual basis entirely based on student need thereby ensuring maximum scheduling flexibility.

Availability of standards-based instructional materials appropriate to all student groups (ESEA)

State adopted curriculum and materials are available to all students as required by the Williams Act.

Use of SBE-adopted and standards-aligned instructional materials, including intervention materials, and for high school students, access to standards-aligned core courses (EPC)

Teachers use all SBE-adopted and standards-aligned instructional material for general education, intervention, and special education needs.

## Opportunity and Equal Educational Access

Students performing below grade level have access to state adopted curriculum and standards based instruction. Teachers provide core instruction to meet the needs of students of all performance levels. Students in need of additional support receive intensive intervention up to 60 minutes daily with their core teacher.

Evidence-based educational practices to raise student achievement

Teachers meet daily to discuss practices that have proved successful with their students. Interventions are formed through collaboration with administration and resources are brought to bear as needed to improve performance.

## Parental Engagement

Resources available from family, school, district, and community to assist under-achieving students (ESEA)

MTSS, ST Math, SPED, 504 plans, tutoring for all, and district supports as needed are available for under-achieving students.

Involvement of parents, community representatives, classroom teachers, other school personnel, and students in secondary schools, in the planning, implementation, and evaluation of ConApp programs (5 California Code of Regulations 3932)

Parent involvement and membership is encouraged at both the site and district levels on the following committees: LCAP Advisory, SSC, and Parent Advisory Committee. Weekly parent meetings are designed to help develop skills, strategies, and techniques to support and or improve their child's academic effort and progress. Parent involvement opportunities include: school socials, field trips, Back-to-School Night, Open House, parent conferences, and classroom volunteering.

### Funding

Home school receives proportional funding through calculations based on student demographic factors for oversight activities and instructional programs. Title I funds are used to support all students performing below proficiency levels.

Home school receives LCAP and district general funds to support student learning.

### Involvement Process for the SPSA and Annual Review and Update

School Site Council met on 4/21/20 to review results of parent surveys and to gather additional input. Teachers provided feedback at subsequent staff meetings. A draft plan was reviewed on 5/9 where feedback was provided. The School Site Council met a final time on 6/3 to review and approve.



The school may include data voluntarily developed by districts to measure pupil outcomes (described in the Identified Need); and
      - b. Be based on academic achievement information about all students in the school, including all groups under §200.13(b)(7) and migratory children as defined in section 1309(2) of the ESEA, relative to the State's academic standards under §200.1 to—
        - i. Help the school understand the subjects and skills for which teaching and learning need to be improved; and
        - ii. Identify the specific academic needs of students and groups of students who are not yet achieving the State's academic standards; and
        - iii. Assess the needs of the school relative to each of the components of the schoolwide program under §200.28.
        - iv. Develop the comprehensive needs assessment with the participation of individuals who will carry out the schoolwide program plan.
        - v. Document how it conducted the needs assessment, the results it obtained, and the conclusions it drew from those results.
  - B. Identification of the process for evaluating and monitoring the implementation of the SPSA and progress towards accomplishing the goals set forth in the SPSA (described in the Expected Annual Measurable Outcomes and Annual Review and Update).

### Requirements for the Plan

- II. The SPSA shall include the following:
  - A. Goals set to improve pupil outcomes, including addressing the needs of student groups as identified through the needs assessment.

- B. Evidence-based strategies, actions, or services (described in Strategies and Activities)
1. A description of the strategies that the school will be implementing to address school needs, including a description of how such strategies will--
    - a. provide opportunities for all children including each of the subgroups of students to meet the challenging state academic standards
    - b. use methods and instructional strategies that:
      - i. strengthen the academic program in the school,
      - ii. increase the amount and quality of learning time, and
      - iii. provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.
    - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
      - i. strategies to improve students' skills outside the academic subject areas;
      - ii. preparation for and awareness of opportunities for postsecondary education and the workforce;
      - iii. implementation of a schoolwide tiered model to prevent and address problem behavior;
      - iv. professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
      - v. strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C. Proposed expenditures, based on the projected resource allocation from the governing board or body of the local educational agency (may include funds allocated via the ConApp, federal funds for CSI, any other state or local funds allocated to the school), to address the findings of the needs assessment consistent with the state priorities, including identifying resource inequities, which may include a review of the LEAs budgeting, it's LCAP, and school-level budgeting, if applicable (described in Proposed Expenditures and Budget Summary).   - 2. Provide sufficient information on which to base effective assistance to those students.
- G. For an elementary school, a description of how the school will assist preschool students in the successful transition from early childhood programs to the school.
- H. A description of how the school will use resources to carry out these components (described in the Proposed Expenditures for Strategies/Activities).
- I. A description of any other activities and objectives as established by the SSC (described in the Strategies/Activities).

The CSI plan shall:

1. Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable);
2. ## **Additional Targeted Support and Improvement**

A school identified for ATSI shall:

1. Identify resource inequities, which may include a review of LEA- and school-level budgeting, which will be addressed through implementation of its TSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities, and Annual Review and Update, as applicable).

## **Single School Districts and Charter Schools Identified for School Improvement**
