

RESOLUTION NO. 20-066

**RESOLUTION OF THE BOARD OF EDUCATION OF THE
BERKELEY UNIFIED SCHOOL DISTRICT FINDING CERTAIN
VEHICLES TO BE NO LONGER NEEDED FOR SCHOOL
PURPOSES, AND NOT SUITABLE FOR SCHOOL USE;
AUTHORIZING THE PUBLIC SALE OF THE VEHICLES; AND
DELEGATING AUTHORITY TO SELL THE VEHICLES
PURSUANT TO CALIFORNIA EDUCATION CODE SECTION 17545**

WHEREAS, the Berkeley Unified School District (“District”) currently owns vehicles specifically listed and identified in Exhibit “A”(collectively, the “Vehicles”);

WHEREAS, the District’s Board of Education (“District Board”) wishes to sell the Vehicles as it is no longer required for school purposes and not suitable for student use;

WHEREAS, section 17545 of the California Education Code authorizes the sale of school district personal property not required for school purposes or not suitable for school use by soliciting bids;

NOW, THEREFORE, the Governing Board of the Berkeley Unified School District hereby finds, determines, declares, orders and resolves as follows:

Section 1. That all of the recitals set forth above are true and correct, and the Board so finds and determines.

Section 2. That the vehicles are not required for District school purposes and are not suitable for school use.

Section 3. That the District Board authorizes District staff to take all necessary action to proceed with the sale of the Vehicles as provided in Education Code section 17545, which may include the use of a third party to conduct the sale(s).

Section 4. That District staff is hereby granted authority to determine the terms of the sale(s), including how the vehicles will be packaged and sold to maximize its overall value.

Section 5. That the sale(s) shall be on an “as is” basis with the buyer(s) responsible for the condition of the vehicles and all associated costs.

Section 6. This Resolution shall take effect immediately upon adoption.
