RESOLUTION No. 20-065

Authorization to Award Contract for West Campus Parking Lot Project #150.2002

WHEREAS, in accordance with Uniform Public Construction Cost Accounting procedures, bids were solicited for #150.2002. Bids were opened on June 9, 2020 at 2:00pm, and the following 3 bids were received and deemed qualified as follows:

CONTRACTOR	Total Base Bid + Alt. 1
Arntz Builders	\$373,468.00
CWS Construction Group, Inc.	\$369,250.00
CF Contracting, Inc	\$686,656.00

WHEREAS, **CWS Construction Group, Inc.** is the lowest bidder and is deemed to be responsive, responsible and qualified to complete the work according to the specifications in project number 150.2002 documents;

WHEREAS, Public Contract Code § 20118.4 authorizes a school district to authorize changes or alterations of a contract without further bidding if the cost does not exceed the greater of either (1) the amount specified in Public Contract Code § 20111 or (2) ten percent (10%) of the original contract price;

WHEREAS, Education Code section 17604 authorizes the Board, by a majority vote, to delegate to the District's Superintendent, or to such persons as the Superintendent may designate, the power to contract, subject to limits as to time, money and/or subject matter as specified by the Board, and provided that the Board approve or ratify the transaction by a motion of the board duly passed and adopted;

WHEREAS, the Board desires to delegate to the District's Superintendent, or to the District's Assistant Superintendent and/or Executive Director of Facilities, the authority at the District's sole discretion to approve change orders for the Project;

NOW, THEREFORE, BE IT RESOLVED that the bid of **CWS Construction Group, Inc.**, for the Total Base Bid and Alternate 1 in the amount of \$369,250 to be accepted; and the Superintendent, Assistant Superintendent, and Purchasing Agent or Executive Director of Facilities of this District are hereby authorized to enter into a contract with said bidder for said amount in accordance with law and to approve change order(s) up to the bid threshold, provided, however, that no such change order made pursuant to this delegation shall be valid or constitute an enforceable obligation against the District unless and until the change order is approved or ratified by the Board, evidence by a motion of the Board duly passed and adopted. Such contracts and/or change orders may be placed on the Board's consent calendar or otherwise, at the discretion of the Superintendent.
