

# Preschool Summer Guidelines

- Licensed preschool & school-age facilities must adhere to:
  - *San Mateo County Health Order*
  - *Community Care Licensing Regulations*
  - *Title V Regulations*
- Bubble cohort
  - *Designated staff, rooms and spaces, no co-mingling*
  - *Minimum of 3 weeks*
- Limited group size and ratio
  - *12:2 per classroom w/state waiver or 10:1 w/out state waiver*

# Preschool Health and Safety Procedures

- Staff training prior to reopening
- Remain in bubble cohort all summer
- Staff and school-age students will wear face mask/coverings
- New drop off and pick up procedures
- Temperature checks & intake questions for staff and students
- Students and staff that are sick will remain home; isolation area
- Maintain consistent hand washing
- Rearrange classroom and individual supply kits
- Frequent cleaning and disinfecting
- Dedicated staggered outdoor time and equipment, and cleaning

# Preschool Summer Reopening Update

- Location
  - *Turnbull state subsidized preschool & school-age 12-month*
- Summer days of operation
  - *July 1, 2020 till August 10, 2020*
- Preschool Summer Model
  - *On-site bubble cohort*
    - 12:2 per classroom
    - Modified hours: T9/T10 from 8:40-4:20 and T11/T13 from 8:50-4:30
  - *Distance learning cohort*
    - Mixture of live small group, live whole group, individual check-in, pre-recorded videos, and packet

# Health and Safety for ESY and General Education Summer Program

- Staff training prior to summer start
- Students and Staff remain in a bubble cohort all summer
- Students and Staff will wear face mask/coverings
- Drop off and pick up procedures will maintain distance with temperature checks
- Students and Staff that are sick will remain home; isolation area
- Utilize consistent hand washing practices
- Utilize cleaning protocols
- Dedicate staggered outdoor time and equipment, and cleaning

# Extended School Year (ESY)

- Bubble cohort
  - Designated staff, rooms and spaces, no co-mingling
  - Minimum of 3 weeks (ours is 19 days)
- 50 Students attending live summer school at the following sites:
  - Laurel (3 classes)
  - Fiesta Gardens (3 classes)
  - Brewer Island (3 classes)
  - Sunnybrae (1 class)
- 28 Students in Distance Learning
- Unique Learning Curriculum
- Virtual SEL and PE lessons through district staff and Star Vista
- All Related Services are virtual

# General Education Program

- Bubble cohort
  - Designated staff, rooms and spaces, no co-mingling
  - Minimum of 3 weeks (ours is 19 days)
- 50 Students attending live summer school at the following sites:
  - College Park (7 classes, Kinder - 4th grades)
  - Sunnybrae (4 classes, 5th - 8th grades)
- Curriculum
  - K-8 Mathematics: Number Talks, ST Math, Math Games
  - K-5 ELA/ELD: Benchmark, Unit 10 and Inquiry Project
  - 6-8 ELA/ELD: **New** MS Academic Acceleration Course Unit, “The Stories We Tell”
- Virtual SEL and PE lessons through district staff and Star Vista
- 1:1 Virtual counseling services through Star Vista
