# Preschool Fall Reopening Guidelines

- Licensed preschool & school-age facilities must adhere to
  - *San Mateo County Health Order*
  - *Community Care Licensing Regulations*
  - *Title V Regulations*
- Bubble cohort
  - *Designated staff, rooms and spaces, no co-mingling*
  - *Minimum of 3 weeks*
- Limited group size and ratio
  - *12:2 per classroom w/state wavier or 10:1 w/out state wavier*

# Preschool Health and Safety Procedures

- Staff training prior to reopening
- Remain in bubble cohort
- Staff and school-age students will wear face mask/coverings
- New drop off and pick up procedures
- Temperature checks & intake questions for staff and students
- Students and staff that are sick will remain home; isolation area
- Maintain consistent hand washing
- Rearrange classroom setup and individual supply kits
- Frequent cleaning and disinfecting
- Dedicated staggered outdoor time and equipment, and cleaning

- North Shoreview and Parkside
  - *Blended Montessori*

  - *Inclusion*
- Turnbull
  - *Mandarin Immersion, AM/PM, PIP, full day state subsidized preschool and school-age*

# Preschool Fall Reopening Model

- On-site bubble cohort
  - *12:2 per classroom*
  - *Regular hours and tuition*
  - *Begins August 12, 2020*
- Distance learning cohort
  - *\$250/month fee-based programs*
  - *Mixture of live small group, live whole group, individual check-in, pre-recorded videos, and packet*
  - *Curriculum similar to on-site, utilize resources from CDE's Early Learning and Care division, San Mateo County Office of Education's preschool department, and current curriculum*

# Enrollment Information

## ■ Fee-based

- *Based on 12:2 some promised families will be in distance learning at the beginning of the year*
- *Additional classroom already opened to bring back more Mandarin families*
- *Staff is working to open one additional classroom for the Montessori programs so that all returning families, employees, and some of the other promised families would have a classroom place (12 students)*
- *Families are welcome to continue distance learning instead of joining the on-site bubble cohort*
- *Full refund of the deposit if families withdraw from the program*

## ■ State-subsidized

- *Began enrolling part day families in May 2020*
- *Begin enrollment for full day programs in July 2020*
