

**IRVINE UNIFIED SCHOOL DISTRICT  
RESOLUTION NO. 20-21-08**

**DESIGNATE THE OBSERVANCE OF LINCOLN DAY HOLIDAY ON  
NOVEMBER 24, 2021 AND NOVEMBER 23, 2022 AND THE OBSERVANCE OF  
“NEW YEAR’S DAY” JANUARY 1, 2023 ON DECEMBER 30, 2022**

**WHEREAS**, Education Code section 37220 provides public schools shall close on specified holidays, including January 1 (“New Year’s Day”) and Lincoln Day; and

**WHEREAS**, Education Code section 37220 provides that when any of the holidays on which schools would be closed falls on Sunday, the public schools shall close on the following Monday; and

**WHEREAS**, Education Code 37220(e) allows for Governing Boards by Resolution to set the date upon which the schools of the district close in observance of any of the holidays listed in Education Code section 37220(a), with the exception of Veteran’s Day; and

**WHEREAS**, the holiday known as Lincoln Day is normally observed on the Monday or Friday of the week in which February 12 occurs; and

**WHEREAS**, for the 2021-2022 and 2022-2023 school years, the District wishes to designate the observance of the holiday known as Lincoln Day on November 24, 2021, and November 23, 2022, respectively, to extend the Thanksgiving break for students and staff, and to provide for an instructional day on the Monday or Friday of the week in which February 12 occurs; and

**WHEREAS**, for the 2022-2023 school year, the District wishes to observe the New Year’s Day holiday of January 1, 2023, on December 30, 2022;

**NOW, THEREFORE, BE IT RESOLVED**, that the Governing Board of the Irvine Unified School District approves the observance of, and school closures on, the holiday known as Lincoln Day on Wednesday, November 24, 2021, and on Wednesday, November 23, 2022, and the New Year’s Day holiday of January 1, 2023, on Friday, December 30, 2022, as set forth in the calendars for the 2021-2022 and 2022-2023 school years.
