**AGREEMENT FOR CONSULTANT SERVICES
FOR THE 2020 – 2021 SCHOOL YEAR**

THIS AGREEMENT is made this **June 2020** between **DONNA C. PATRICK**, hereinafter called the Contractor, and **NEWHALL SCHOOL DISTRICT** hereinafter called the District.

The Contractor agrees to perform services for the District as follows:

The Contractor will provide services to the assistant superintendent, human resources, during the 2020-21 school year as delineated in the attached Scope of Work.

The District agrees to pay the Contractor an amount **not to exceed NINE THOUSAND EIGHT HUNDRED DOLLARS (\$9,800)** for services provided which includes mileage and materials. The Contractor will submit semi-annual invoices to the District. Payments are due within 30 days of receipt of invoice.

Contractor agrees to hold harmless and indemnify the District, its officers, agents, and employees with respect to all damages, costs, expenses or claims, in law or in equity, arising or asserted because of injuries to or death of person or damage to, destruction, loss, or theft of property arising out of faulty performance of the services to be performed by Contractor hereunder.

It is expressly understood and agreed to by both parties hereto that the Contractor, while engaged in carrying out and complying with any of the terms and conditions of this contract, is an independent contractor and is not an officer, agent, or employee of the aforesaid District. Either party may terminate this agreement by providing the other party with ten (10) days written notice. Upon such termination, fees will be determined on a pro rata basis.

The District understands that the work/services provided should not be considered creditable toward the STRS earnings limit as the work is not normally performed by employees of the District and requires less than 24 months (496 business days). REF. CA Education Code § 26135.7 (2014)
