Student Supervision

There is an anticipated need for the supervision of children of essential workers before or after in-person learning (i.e., during their daily distance learning time).

- TK-6: Supervision so essential workers can continue to work
- 7-12: Provision of a place on campus where students lacking internet at home can complete distance learning activities



Student Supervision

Approximate cost for one coordinator + 4 elementary and 4 JSHS positions would be \$450,000 (salaries, benefits, supplies).

- Could be funded by CARES Act, Title I, site funds
- Limited space due to requirements of social distancing, approx. 15 at each site.
- Could trim the budget by only having the program in communities demonstrating the greatest need.

Special Education Classified Staffing

- The number of FTE will change depending on re-opening phase
- Each program (SDC, RSP, speech) to be assigned aide support based on student count, approximately 0.8 FTE per full program
- Special Circumstance Instructional Aides (SCIA) to be assigned per board-adopted process. LVNs to be assigned in cases of significant medical need
- Workability coordinator and vocational counselors assigned based on student counts
- Job descriptions may be updated to include cleaning and screening.



Special Education Classified Staffing

Approximate FTE to rescind based on re-opening phase (depends on actual student count)

	Phase I (Full Distance)	Phase II/III (Blended)	Phase IV (Full Re-open)

Credentialed School Nurse Staffing

- Credentialed School Nurses can perform all duties required under Ed. Code
- Classified nurses (RNs, LVNs) require significant oversight by credentialed staff
- The District can provide comprehensive services more efficiently by staffing with credentialed nurses when possible
- The addition of a 1.0 FTE Credentialed School nurse position for the 20-21 school year would allow a credentialed nurse presence at each school on a rotational basis.

Outdoor Core- supporting teachers with implementation of Next Generation Science Standards (NGSS), Learning Landscapes, field journals, etc...
