The Nutrition Services Department provides food, paper and janitorial supplies to Modesto City. The annual cost exceeds the current bid threshold of \$250,000; therefore, competitive bids were solicited.

Bid #20-4728 Nutrition Services Food Products and Bid #20-4729 Nutrition Services Manufacturer Direct Ship Food Products are advertised as required by law. Bid # 20-4728 was sent to seventy-eight (78) vendors with seven bid awards are for one (1) year, with the option to renew for two (2) additional one-year period.

Bids are awarded to the lowest cost responsive and responsible bidders for each line item and the estimated annual cost.

The estimated annual cost for the combined purchases is \$6,518,000 to be funded by the Nutrition Service.
