"Compensation and Payment" of our Agreement approved by the BOT 02/18/16 is hereby modified to allow for the additional fees required to implement the above changes. The present fee of architectural services of \$281,749.00 is hereby increased by a not-to-exceed fee of **\$15,728.00**, (Exhibit A) for a fixed fee of **\$297,477.00** for the architectural services.

The new contract amount is **\$297,477.00**.

The contract completion date of the project after receiving the Amendment changed to the summer of 2020.

All other conditions of our Agreement (and subsequent Amendment(s) set forth above) remain in full force and effect as originally stated.
