

**Escalon Unified School District
Resolution Authorizing Transfer of Funds**

Resolution No. 20-21-04

Whereas, Education Code 42600 and 42602 provides that the Board of Trustees of Escalon Unified School District may, by majority vote, transfer funds between the undistributed reserve and any expenditure classification and with the approval of the County Superintendent of Schools budget and use unbudgeted income provided during the fiscal year from any source other than local property taxes or the State School fund, and

Whereas, Board of Trustees of Escalon Unified School District authorizes Ron Costa, Superintendent, to make appropriation transfers;
