With this plan in the 50% Hybrid Model, Mondays would be all virtual for all 7 -12 Learners. Cohort A would attend on Tuesday and Wednesdays, Cohort B would attend on Thursdays and Fridays. Cohort C would always be virtual. Teachers would live -stream synchronously for approximately 40 minutes of their direct instruction each period to provide for the virtual learning cohort each day. Office hours each day would be designed for follow -up questions and support for the day's distance learning cohort. Virtual learners would be assigned 40 minutes of additional guided practice once the synchronous direct instruction completed; in -person learners would engage in guided practice with the teacher in the classroom.

During the designated Office Hour block, Special Education and ELD Supports will also be provided. Office Hours also provide time within the contractual day for students requiring academic support; Office Hours are targeted in the Hybrid Model for the students in virtual learning on a given day. On a block day without a prep period, office hours become the teacher prep period. 6/5s assignment teachers select 1 day in the two -day block to offer Office Hours.

With this plan in the 50% Hybrid Model, Mondays would be all virtual for all 7 -12 Learners. Cohort A would attend on Tuesday and Wednesdays, Cohort B would attend on Thursdays and Fridays. On a block day without a prep period, office hours become the teacher prep period.

Secondary (LCHS 7-12) Hybrid Schedule #2

Recommendation for Mitigating Health Impacts

- Hybrid schedule begins January 5, 2021 (if allowed by DPH)
- Prior to 1/5/2020, if LCUSD is allowed to reopen in a hybrid model, LCUSD will reopen LCHS 7-12 by providing for cohorted (1:12) on-campus virtual instruction for those who apply
- # of days per week will depend on the # of applicants (minimum 1 day/week)
- LCUSD is able to accommodate 39 cohorts of 12 students per day (468 students/day)
- Cohorts will be supervised by paraprofessionals, substitute teachers, and administrators
- Cohorts will not mix
- Cohorts will be arranged by grade level and at least 1 friend request will be honored
- Lunch will be in an assigned outdoor area
- This will allow teachers to work with Tech Department and District admin to design and optimize their workspaces and PPE for Hybrid reopening on January 5 (if allowed by DPH)
- This will allow students to be back on campus in a non-mixing cohort to maximize safety, limit exposure, minimize contact tracing
- Allows LCUSD Administration to pilot Student Arrival and Outbreak Exposure Protocols
