6.1. Discussion of Process Related to SRO Resolution

Dr. Rosas welcomed to the Study Session Drew Corbett, City Manager of the City of San Mateo, Ed Barberini, Chief of Police for the City of San Mateo and Nicole Anderson, Facilitator.

Trustees Corzo and Watkins shared the purpose of the SRO Resolution. Nicole Anderson, reviewed the actions in the Resolution including the termination of the SRO contract and the redefinition of the role of policing in the schools.

Dr. Rosas noted that the purpose of the Study Session is to discuss ways to outreach to the school community and the greater community with the police partners. The information gathered will be utilized to update the Discipline Matrix, Safety Plans and policies and practices in the District.

Chief Barberini shared information about the SRO work with the students in the schools and City Manager Corbett shared his positive experience in working with the District. Both Chief Barberini and City Manager Corbett are looking forward to working together to better serve the students in the community.

The Board continued their discussion about the purpose of the SRO program and the need to define their vision of the success of the Resolution to prepare questions for the staff, families and for community outreach. Ms. Anderson noted that this is the first of several engagement meetings to redefine the SRO Program and that the goal of the Study Session was to facilitate a process by discussing the following questions:

- What will success look like and how will it be measured?
- What questions do we want to ask staff, families, and students?
- How will we conduct outreach to our community to engage all voices?
