# Special Education Local Plan Area

- 1977, all school districts and county offices of education were mandated to form consortiums in geographical regions of sufficient size and scope to provide for all special education service needs of children residing within the region boundaries.
- Each region, Special Education Local Plan Area (SELPA), developed a local plan describing how it would provide special education services.

# Solano County SELPA

- Provide case level support for districts
- Provide teacher mentoring
- Manage all nonpublic school billing and monitoring
- Maintain a pool for residential placements
- Maintain a legal defense pool and a legal education pool

# Solano County SELPA

- Every SELPA is unique
- SELPAs operate based upon the direction of the governing body
- The governing body of the Solano County SELPA is the Council of Superintendents

# Revision of Every Local Plan

- AB 1808 - Education omnibus trailer bill
  - Required the Department of Education to develop template forms for local plans
  - Requires SELPAs to revise the local plan using these templates
  - Requires review of the local plan every three years
  - Requires posting on the website of every LEA



# Solano County SELPA Local Plan Revision

- Before AB 1808, the Solano County SELPA was working to revise and update the local plan
- The local plan revision was drafted based upon the preexisting local plan and reviewed with stakeholder groups that formed the Local Plan Workgroup
  - 20 meetings during the 2019-2020 school year to discuss the local plan draft
