Dear Superintendent Dewan,

I write this letter to express my interest in joining the Santa Clara County Committee on School District Organization, representing District 4.

I have served our community for many years, including serving for 6 years on the Santa Clara Unified School District Board as a Trustee, Vice-President and Clerk. During that time, I have also served on the board of the Santa Clara County School Boards Association as President, Vice-President and Hoffmann Awards Co-chair. For the last 4 years, I have been a delegate to the California School Boards Association and was recently selected as one of 9 members of their Nominating Committee.

I began my involvement in Education shortly after becoming a parent, volunteering in my children's classrooms for 18 years. I was a classroom parent coordinator, field trip coordinator, fundraising chair, parent organization treasurer, site council member and had numerous other roles at the schools my children attended. This regular involvement in classrooms led me to become a substitute teacher for 8 years, teaching in schools around the district. My 3 children are graduates of Santa Clara Unified schools.

In 2011, I co-founded a non-profit, Santa Clara Unified Parents, to bring parents together to support our district schools. For 4 years, I chaired our primary project, a district-wide science fair for over 300 students per year, including fundraising, gathering volunteers and coordinating the 2-day event. I co-authored the ballot statements for 3 measures that came out of our recommendations. All 3 passed overwhelmingly by the voters in the city.

My resume is attached with additional details. I have a long-standing commitment to our schools, our students and our community. I would be honored to serve on the Committee on School District Organization.


