No guarantee is made as to SOS's time of arrival; however, SOS requests that they be permitted at least **3 hour(s) Total before** the engagement for set-up and **1.5 hour(s) after** the engagement for tear down.

VII. Cancellation and Amendments

This agreement cannot be terminated except by mutual written consent of both the Client and SOS. If termination is initiated by Client, it must be done so in writing and agreed to by SOS in writing. Termination of event within less than TWO WEEKS prior to listed date will result in a \$500.00 cancellation fee or 25% of Performance fee-whichever is greater. Client will also be required to pay (in addition to the cancellation fee) any unrecoverable costs already incurred by SOS (but not more than the total fee agreed upon).
