**RESOLUTION OF THE BOARD OF EDUCATION OF THE  
IRVINE UNIFIED SCHOOL DISTRICT ENTERING  
ELECTION RESULTS INTO THE MINUTES AND  
CERTIFYING TO THE BOARD OF SUPERVISORS OF  
ORANGE COUNTY ALL PROCEEDINGS IN THE JUNE 7,  
2016 GENERAL OBLIGATION BOND ELECTION**

**WHEREAS**, the Board of Education (“Board”) of the Irvine Unified School District (the “District”) established the Schools Facilities Improvement District No. 1 (“SFID No. 1”).

**WHEREAS**, the Board previously adopted a resolution requesting Orange County (the “County”) to call an election for general obligation bonds within the boundaries of SFID No. 1 (the “Bond Election”) to be held on June 7, 2016; and

**WHEREAS**, such resolution was duly delivered to the Registrar of Voters/County Clerk-Recorder of the County; and

**WHEREAS**, notice of the Bond Election was duly given; and

**WHEREAS**, on June 7, 2016, the Bond Election was duly held and conducted for the purpose of voting on a measure for the issuance of bonds of the District on behalf of SFID No. 1 in the amount of \$319,000,000 (“Measure E”); and

**WHEREAS**, the Board has received from the Orange County Registrar of Voters the Canvass Certificate and Official Statement of Results (the “Canvass”) of the Bond Election; and

**WHEREAS**, it appears from the Canvass, a copy of which is attached hereto as Exhibit A, that more than fifty-five percent of the votes cast on Measure E were in favor of issuing the aforementioned bonds.

**NOW, THEREFORE**, be it resolved, determined and ordered by the Board of Education of the Irvine Unified School District as follows:

**Section 1.** That entry be made upon the minutes of the meeting that Measure E has been approved by more than fifty-five percent of the votes cast at the Bond Election.

**Section 2.** That all proceedings of the District in connection with the Bond Election have been accomplished according to law.

**Section 3.** That the Clerk of the Board is hereby requested to deliver a copy of this Resolution with the Canvass to the Orange County Superintendent of Schools and the Clerk of the Board of Supervisors of the County.


