### Board Bylaws

#### Annual Organizational Meeting

The Board of Education shall hold an annual organizational meeting fifteen days on or after the first Friday in December. (Education Code 35143)

At this meeting the Board shall:

1. Confirm the appointment of president.
2. Elect a vice president/clerk from its members.
3. Elect a Legislative Liaison and Yolo County School Boards Association Representative.
4. Appoint the Superintendent as secretary to the Board.
5. Authorize signatures.
6. Develop a schedule of regular meetings for the year.
7. Develop a Board calendar for the year including evaluation of the Board and the Superintendent, budget meetings and goal setting.
8. The Board president shall ~~designate representatives~~ designate committee assignments and Board liaisons as established in BB 9130, including:

~~The City/District 2x2 is comprised of two appointed board members and two appointed city council members. In addition, the superintendent, city manager, and other appropriate staff attend the meetings.~~

~~The Real Estate Assets Subcommittee is comprised of two appointed board members, two appointed city council members, and appropriate agency staff to review, discuss and make recommendations regarding the district's real property.~~

~~The Superintendent's Evaluation Subcommittee is comprised of two appointed board members to facilitate the annual Superintendent evaluation process.~~

~~The Budget and Fiscal Subcommittee is comprised of two appointed board members and the~~

~~Associate Superintendent of Business Services.—The subcommittee members review various budget documents including budget guidelines and serve as liaisons to the board and community.~~

~~The Board Policy Review Subcommittee is comprised of two appointed board members to review and update board policies.~~

~~The UCD Partnership is comprised of two appointed board members to facilitate ongoing collaboration with the University.~~

~~CSEA Liaisons—Two Board members are appointed to serve as liaisons and to facilitate communications between CSEA and the Board.~~

~~DTA Liaisons—Two Board members are appointed to serve as liaisons and to facilitate communication between DTA and the Board.~~

~~The Green Schools Subcommittee is comprised of two appointed board members to promote the green schools model.—The subcommittee will study energy use, recycling, and related issues in the school district.~~

#### Election of Officers

The Board shall each year elect one of its members to be vice president/clerk. This member shall be one who previously has not served in office, unless all the Board's members have previously served in office. An individual board member may decline the nomination of vice president/clerk. After serving one year as vice president/clerk, the elected member shall serve one year as president of the Board.

When the only members who have not served as officers are new to the Board, the Board may elect as vice president/clerk a Board member who has served in office.
