SECTION 1 INTRODUCTION

Significant Events During the Reporting Period

Over the past four years the Elk Grove Unified School District has built and maintained a comprehensive safety program, which in addition to a law enforcement support component, also includes site safety planning, continued development and utilization of mental health support, extensive training and development of all district staff, and training and development of site safety teams, to name a few. All our efforts were developed with a primary emphasis on supporting other district programs like mental health support and counseling, PBIS and restorative justice.

As background, at the direction of the Superintendent, the Director of Safety and Security and the Deputy Superintendent of Education and Schools conducted a review of the safety, security and Division of Safety and Security policies and procedures employed by the district. As a result of this comprehensive review several recommendations were made to the Superintendent for consideration and approval.

The Superintendent directed that new policies be developed to guide the decision making process for both district administrator and law enforcement when issues of student discipline and/or criminal conduct occur. This action resulted in the development and adoption by the Elk Grove School District Board of Education of BP and AR 5144.3.

The Superintendent, further directed that a new safety and security model be developed that addressed current safety concerns, complied with recent changes in both state and federal laws, complied with the requirements of BP 5144.3 and was economically feasible. A major change in the new model was the removal of all School Resource Officers from the schools and have not had law enforcement officers assigned to individual schools for over a year.

Our law enforcement support team was reassigned from a “site-based” deployment model to a “region-based” deployment model. As you are aware, we have nine regions, with one school resource officer and one safety security specialist assigned to each region as opposed to being assigned to a specific schools.

SECTION 1 – INTRODUCTION (Continued)

In this revised regional approach, safety and security support is provided to all the schools within each region. The middle schools and high schools have campus security staff and the elementary schools have yard duty staff who also provide safety and security support to their schools and to the regional school resource officer and safety security specialist. This new model was approved by the Elk Grove School District Board of Education and implemented during the 19/20 school year.

Under our model, law enforcement is only called to a school when it is required or permitted by our own policies and procedures, which have been reviewed and approved by our legal team and are in compliance with all state and federal laws.

Additionally, The Superintendent required that measures be implemented to assure quality service delivery and full transparency in all safety, security and Division of Safety and Security operations was maintained. This effort has taken four primary forms:

1. The Division of Safety and Security collects data related to incidents occurring on District sites related to crime and conduct. Daily summaries are distributed to Division of Safety and Security staff and law enforcement partners as well EGUSD Executive staff.
2. The Director of Safety and Security provides quarterly statistical reports to the Superintendent on the overall operation of the department with an emphasis on special event categories. Examples of special event categories include Mental Health (WandI 5150) Evaluations, Mental Health Holds (WandI 5150) where a Casualty Report is generated, Threat Assessments, School or Support Center Lockdowns and Student Arrests. These efforts will culminate in an annual statistical report to the Board of Education and the Superintendent.
3. The Director of Safety and Security provide an annual status report to the Board of Education at the conclusion of each school year. The report includes progress measures and goals set for the following year.

4. The Division of Safety and Security will work with Research and Evaluation to administer an annual survey. The survey is intended to gather feedback from a broad base of stakeholders focused on their level of confidence in services provided. This data will be used for continuous improvement and reported to the Board and the stakeholder groups.

SECTION 2

OVERVIEW: DIVISION STRUCTURE AND FUNCTIONS

EGUSD DIVISION OF SAFETY AND SECURITY – MISSION STATEMENT

To protect life and property and to ensure the academic tranquility of the staff and students of the Elk Grove Unified School District.

The safety of students, staff, and visitors to all schools and support facilities in the EGUSD is the Division of Safety and Security Services' top priority. The Division of Safety and Security works in partnership with Education Services and Schools, Business Services and Facilities, Human Resources, the Sacramento County Sheriff's Office, and Elk Grove Police Department to provide for the protection of people and property, 24 hours a day, seven days a week, 365 days a year.

It is the intention and aspiration that the Division of Safety and Security makes a positive impact on not only the educational community, but the greater shared community. Programs such as the Youth Outreach and Community Outreach initiatives embody the Division's primary desire to work collaboratively with EGUSD staff and members of the community. This work is realized when the Division of Safety and Security is recognized by the community as an ally in enriching the lives of the community's youth population and fostering a positive harmony for education.

JURISDICTIONAL DESCRIPTION

The Elk Grove Unified School District is located in one of the most diverse areas of California. The district covers 320 square miles and includes the communities of Florin, Franklin, Laguna Creek, Laguna West, Rancho Murieta, Sheldon, Sloughhouse, Valley Hi, Vineyard, Wilton, all of the City of Elk Grove and parts of the cities of Sacramento and Rancho Cordova. Students speak more than 110 languages. With an annual average of 63,000 students that attend our schools: 13 percent are African American, <1 percent are American Indian, 23 percent are Asian, 6 percent are Filipino, 26 percent are Hispanic or Latino, 2 percent are Pacific Islander, 21 percent are White and 9 percent are Multiple/No Response.

As EGUSD is located entirely within the County of Sacramento, there are five general law enforcement jurisdictional boundaries that share the District's territory. These include:

1. the California Highway Patrol
2. the Elk Grove Police Department
3. the Rancho Cordova Police Department
4. the Sacramento Police Department
5. the Sacramento County Sheriff's Office

Within these jurisdictions the EGUSD operates 42 elementary schools, nine middle schools, nine comprehensive high schools, four alternative education schools, one charter school, one virtual online K-8 program, one special education school and one adult education school. In addition, the district offers preschool programs at 15 school sites, an adult education program and a career training center for adults. Safety and Security Services is responsible for all district schools, support facilities, and their immediate surrounding areas.

ORGANIZATIONAL MAKE UP

The EGUSD Safety and Security Services employs five supervisory positions (Director, Assistant Director, and three Managers), as well as 11 School Security Specialists. Nine School Security Specialists are assigned to support each of the nine regions. One School Security Specialist is assigned to support the Campus Supervisor program (hiring, training and uniforms) as well as the District two-way Radio Program. One School Security Specialist is assigned to the security of the Student Support Center and District Camera Program. There is also one Administrative Assistant III assigned as support for administration.

In July of 2018, the EGUSD Division of Safety and Security began operation of a 24 hour / day dispatch center. There are six dispatchers who work three different shifts. Dispatchers are responsible for taking telephone and two way radio calls for service from EGUSD site and support center employees as well as from community members and law enforcement agencies. Additionally, the dispatchers monitor the district fire and intrusion alarm systems as well as the district camera system.

EGUSD has a Memorandum of Understanding and underlying contracts and agreements with the Sacramento County Sheriff's Office and the Elk Grove Police Department. The Sacramento County Sheriff's Office provides 9 sworn peace officer positions (one Lieutenant, one Sergeant and seven Deputies as School Resource Officers. The Elk Grove Police Department provides 2 Police Officers and combined with the 7 Deputies that cover the nine Comprehensive High School Regions. In addition, the Deputies / Police Officers cover the four Alternative/Continuation High Schools/Assist SARB).

SAFETY AND SECURITY SERVICES PROVIDED

EGUSD patrol services are provided 24 hours a day by EGUSD Division of Safety and Security and by our law enforcement partners. They respond to all district schools' calls-for-service, crimes in-progress, threat assessments, crime reports, administrative assistance requests, conflict resolutions, and intrusion/fire alarms. They also provide regular school site checks to deter break-ins, vandalism, trespassing, and peace disturbances.

The Division of Safety and Security and law enforcement partners conduct all follow-up criminal investigations of crimes committed on school district property. In addition, Security and Safety Managers conduct administrative investigations as needed.

The Division of Safety and Security implements several proactive approaches to maintain school safety including, but not limited to, the following: Comprehensive Safe School Plans at every school, Emergency Procedures Guidelines, Emergency Guidelines Flipcharts, closed campuses, monitoring the Catapult EMS Program, and other student and staff safety presentations.

COMPREHENSIVE SAFE SCHOOL PLANS

The Division of Safety and Security provides the management and oversight of 66 total Comprehensive Safe School Plans. California Education Code sections 32280-32289 require each school to prepare an annual Comprehensive Safe School Plan dealing with violence prevention, emergency preparedness, crisis intervention, and student and employee safety. This is accomplished by using a seven-step process:

- Step 1 – Identify school's planning committee members
- Step 2 – Create vision of school
- Step 3 – Gather and analyze data
- Step 4 – Identify areas of change and set major goals
- Step 5 – Write Comprehensive Safe School Plan narrative
- Step 6 – Communicate safety plan to the public
- Step 7 – Evaluate progress and revise plan

The Comprehensive Safe School Plans also need to identify appropriate strategies and programs that will promote school safety and a safe and orderly environment conducive to learning. The following district-wide and/or school specific policies and procedures are included in each plan.

- Emergency Procedures Guidelines
- Child abuse reporting procedures
- School discipline and suspension/expulsion policies
- Procedures to notify teachers of dangerous pupils
- Discrimination, harassment, and bullying policies

- School-wide dress codes prohibiting gang-related apparel
- Procedures for safe ingress to and egress from school
- Hate crime reporting procedures
- EGUSD Parent and Student Handbook
- School's Accountability Report Card
- School Evacuation and Reunification Plan

All schools are required to maintain a copy of their Comprehensive Safe School Plan for public viewing upon request. A copy of each school's safety plan narrative is forwarded to the Division of Safety and Security for review and approval and is archived.

EMERGENCY PROCEDURES GUIDELINES

The purpose of the Emergency Procedures Guidelines is to provide guidance to EGUSD officials, school site administrators, and program managers as to the appropriate management of personnel and material resources in the event of an emergency or disaster. It is divided into two sections: 1) School Emergency Procedures and 2) District Emergency Procedures. A copy of the Emergency Procedures Guidelines is maintained in the Comprehensive Safe School Plan for each school.

Emergency Guidelines Flipcharts were designed to synopsise the Emergency Procedures Guidelines and to give immediate guidance to teachers, staff, and support personnel. The yellow Emergency Guidelines Flipchart is designed specifically for the school setting and has been placed in every classroom, school office, gymnasium, multi-purpose room, library, etc. The orange Emergency Guidelines Flipchart is designed to support the business and administrative staff within the school district and has been provided to the Education Center and every department within the district.

The Division of Safety and Security developed Evacuation and Reunification Procedures. These procedures provide a systematic and safe evacuation of a school site, an efficient and timely reunion of students with their parents/guardians, and an accounting of all students and staff after a major event. A non-tactical overview of the Evacuation and Reunification Procedures is included in each school's Comprehensive Safe School Plan.

SECTION 3

IMPACT REPORT SYNOPSIS

This report – the EGUSD Annual Division of Safety and Security Impact Report, 2019 – 2020 School Year – encapsulates the Division’s activities, trends, and collaborative partnerships, both within and outside the District, including the Sacramento County Sheriff’s Office (SSO) and the Elk Grove Police Department (EGPD).

Please bear in mind that there are two primary objectives of the Impact Report: first, to report on all Division of Safety and Security activity over the last school year with absolute transparency, and second to illustrate the ways in which the Division of Safety and Security provides a valuable service to the communities that comprise the EGUSD; that Division of Safety and Security contributes to the community in a meaningful, positive manner.

To that end, the Impact Report is organized into the following sections:

Introduction

A background summary of the need and subsequent policies that brought about the generation of an annual Division of Safety and Security annual report. Also included is establishing information as to the method in which the Division collects activity data.

Overview – Division Structure and Functions

Contains the Division of Safety and Security mission statement, the jurisdictional description, the organizational structure and function, and law enforcement services provided.

Impact Report Synopsis

Provides descriptions and explanations of the information included within the Impact Report.

Event Statistics

Delivers a numerical representation via percentages of the events (calls-for-service) that the Division of Safety and Security engaged in and reports generated during the 2019-2020 school year. The various statistical categories illustrate the current climate of the EGUSD’s youth population, as it relates to criminal activity, threats to life and a peaceful educational environment, and the general safety and security of staff and students. Furthermore, event statistics identify resulting response action taken by the Division of Safety and Security to satisfy calls-for-service.

Event Totals by Category

Provides a “raw-numbers” numerical count of the Division of Safety and Security events responded to and reports taken during the 2019-2020 school year. The event categories are tracked and examined by increasingly specific criteria. This information is a valuable factor in determining how to best respond to the needs of the EGUSD community, the primary focus being to ensure the safety and security of the staff and students.

Event Totals by Site

Gives an alternative view, based on the EGUSD site, of the “raw-numbers” numerical count of the events the Division of Safety and Security responded to. This information is beneficial to identify trends where Division of Safety and Security is most needed. Furthermore, identification of trends assists with wise planning and allocation of resources in order to be proactive in problem solving, as opposed to reactive.

Four Year Event and Special Categories Comparisons

Via data-graph representation, this section will provide a visual illustration of formal law enforcement reports generated during a standard calendar year and how that data compares to the prior four years. This information is valuable in determining the trends in which different types of crimes affect the EGUSD community. Furthermore, this information is vital in determining appropriate proactive measures in which to ensure the safety and security of the EGUSD’s staff and students.

Special Category Demographics

Special Category events / reports are incidents in which a higher level of law enforcement action is employed. These incidents result in formal law enforcement reports being generated and often require that the detainment of a person is necessary, to ensure the safety and security of EGUSD community. Because it is vitally important to maintain impeccable ethical standards of fair and unbiased treatment of all people, Special Category demographics are tracked and presented for transparent examination and consideration.

Proactive Training Initiatives for Community Oriented Safety and Security Services

Regarding on-campus, front-line safety and security, Division of Safety and Security staff are charged with the primary mission of maintaining the safety and security of the institution. Of course the most effective method in which to realize this mission is to work collaboratively, via positive and proactive initiatives, with the staff, students, student’s caretakers, and the general community. To that end, Division of Safety and Security conducts numerous training events throughout the year – training disseminated to Division of Safety and Security staff members, and at times all District staff. Training subjects include: community based service, fair and equitable treatment of all people at all times, understanding human behavior, principals of sound proactive site security, emergency response procedures, and youth mentoring.

SECTION 3 – IMPACT REPORT SYNOPSIS (Continued)

Community Outreach and Youth Services

The Division of Safety and Security's Community Outreach and Youth Services initiatives include close partnerships with the Sacramento County Sheriff's Office, most notably the SSO Youth Services Unit. The mission of the Community Outreach and Youth Services initiative work collaboratively with community partners to enrich the lives of the District's youth, through positive influence of example and mentoring.

Embedded within this mandate is the objective that this outreach effort with engender a desire for education and a deterrent to engage in youth violence. To that end, Division of Safety and Security regularly conducts youth activities designed to encourage growth, both emotional and academic. Furthermore, Division of Safety and Security outreach involves and mentors local youth through social, educational, recreational, and leadership activities, which will deter crime, increase self-esteem, and promote a positive relationship with law enforcement.

EVENT CATEGORIES, EVENT TYPES, AND REPORT TYPES – EXPLANATIONS

Events

The Division of Safety and Security engages in many different activities during a seven-days-a-week period, or in a more focused view, a 24 hour day. These activities occur during school hours, off hours, and at after-school functions and athletic events. These activities include interactions with students, parents, school staff, and the general community.

The Division of Safety and Security provides general EGUSD property patrol; and patrol operations are conducted in cooperation and coordination with outside agencies. Most of these activities are routine in nature and do not rise to the level of documentation. Some, as will be described in the following section, rise to the level of formal law enforcement reports while others are documented as recorded "events".

Division of Safety and Security events are computer file synopses of meaningful calls-for-service and other activities that are more than routine in nature but, in general, do not rise to the level of a formal report. The event categories include Reports, Admin Assist, Assist Citizen/Student, Assist Outside Agency, Fire Alarm, Intrusion Alarm, Canine Program, Peace Disturbance, Further Investigation, Information Received/Be On The Lookout (BOLO), Special Assignment (SPAS)/Directed Patrol, Suspicious Circumstance/Person, Truant, Threat Assessment, Vandalism (No Report), and Miscellaneous.

Major Report Categories

The Division of Safety and Security responds to numerous calls-for-service and activities on a daily basis. Some of these calls-for-service and activities rise to the level where law enforcement reports are necessary to document a crime or a special circumstance. These reports are broken down into four major categories; Person Crime Reports, Property Crime Reports, Other Crime Reports, and Non-Crime Reports.

SECTION 3 – IMPACT REPORT SYNOPSIS (Continued)

Person Crime Reports

Person Crime Reports are considered to be the highest priority of reports and have the most impact on EGUSD's students, staff, and visitors. They represent criminal acts that affect the immediate safety and welfare of individuals. They include physical assaults (misdemeanor and felony), sexual assaults, robberies, kidnappings, and murders.

The Division of Safety and Security has continued increased patrols in and around the District's high schools and middle schools where these crimes were most frequent. School Resource Officers work with their schools' administrations to recognize and diffuse circumstances that could escalate into criminal behavior.

Property Crime Reports

Property Crimes have more of a fiscal impact on EGUSD, its students, staff, and visitors. They include acts such as arson, burglary, theft, and vandalism. The Division of Safety and Security has continued increased patrols around the schools, especially during off-hours when these types of crimes most frequently occur. Community outreach and the We-Tip Program were instituted to encourage neighbors and witnesses to report suspicious circumstances and crimes. The Division of Safety and Security also sends out educational correspondence to the schools instructing them how to better safeguard their sites.

Other Crime Reports

Other Crime Reports are second in importance to Person Crime Reports. Other Crime Reports include criminal threats, weapon possession, controlled substances, and school disruptions. Similar to Person Crimes, the Other Crimes continued at its lowest level with 47 reports in 2014.

Non-Crime Reports

During the Division of Safety and Security's response to calls-for-service and other activities, there are circumstances encountered that, while not rising to the level of a criminal act, require documentation with a law enforcement report. This category is called Non-Crime Reports which includes documentation of significant non-crime incidents, missing and found persons, injuries, vehicle accidents, etc.













SECTION 10 COMMUNITY OUTREACH AND YOUTH SERVICES

Community Outreach and Youth Services

The Division of Safety and Security's Community Outreach and Youth Services initiative partners closely with the Sacramento County Sheriff's Office, most notably their Youth Services Unit. The mission of the Community Outreach and Youth Services initiative is to work collaboratively with community partners to enrich the lives of the District's youth, through the positive influence of example and mentoring. Embedded within this mandate is the objective that these outreach efforts will engender a desire for education and be a deterrent to youth violence.

To that end, the Division of Safety and Security regularly conducts youth activities designed to encourage growth, both emotional and academic. Furthermore, the Division of Safety and Security's outreach efforts involve mentoring the District's youth through social, educational, recreational, and leadership activities. These initiatives are designed to deter crime, increase self-esteem, and promote a positive relationship with law enforcement.

The Florin High School Law Academy is one of only six programs throughout California to be designated as an official partner of the California State Bar Association. The mission of the program is to increase diversity in the legal profession. This program connects students with the skills and opportunities to be competitive in the job market. Over 50 students were in attendance, receiving presentations from ACT, SED, Academy, K9, and STAR deputies. YSU deputies are regularly on campus and participate in classroom. This SAL/Sheriff-sponsored academy trip was the culminating activity for the Florin High School Law Academy school year.
