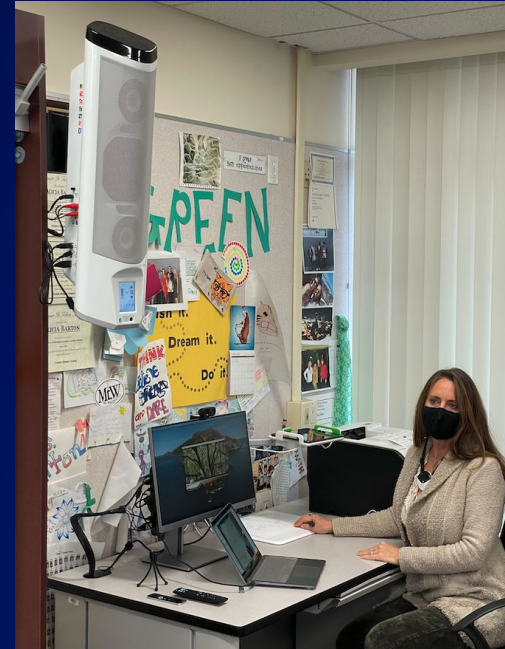
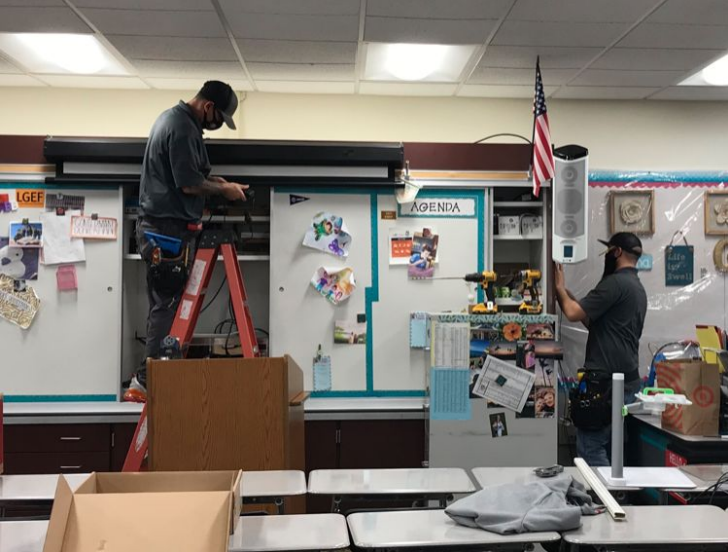

Staffing Update

- ◎ 9 substitutes to support Rooming/Zooming
- ◎ 3 substitutes to replace teachers on leave/resignations
- ◎ 10 long term distance learning subs
- ◎ 15 Hybrid Learning Support Aides

Targeted Support for Students

- Teacher recommended (Administrator approved)
 - In-person zoom from school for students with unstable internet connections, distracting home environments, or needing additional adult direction.
 - Afternoon in-person academic support students with identified academic or productivity concerns.
 - Afternoon social-emotional club/activity opportunities (virtual or in-person).

Technology Update

- ◎ Teacher Toolkit Expansion Installation
 - 1st & 2nd grade "Priority Rooms" - Done
 - Fisher to be completed this week
 - LVM 98% Complete (except K)
 - 3rd-5th to be completed early next week
- ◎ 1-to-1 Teacher "Tech Checks" are underway & are being scheduled
- ◎ 1:1, 24/7 Chromebook 3rd-5th Program
 - Scheduled to begin week of January 18th

New State Guidelines

- ⦿ Schools may reopen if they submit a COVID-19 Safety Plan to both local and state officials
- ⦿ County must have 7-day avg. case rate of less than 28 cases/100,000 people per day to implement plan
- ⦿ Support for student and staff testing and recommended regular testing for both groups
- ⦿ Staff should wear surgical masks
- ⦿ School staff prioritized for vaccines (Phase 1B)

Support for Safe Reopening

- ⊙ Proposing \$2B to support schools that safely open in February and March.
- ⊙ Funds subject to legislative approval as part of the Governors 2021-22 Budget. From State 20-21 budget surplus
- ⊙ Funds weighted for those students disproportionately impacted
- ⊙ Subsidy to reduce portion of student testing costs
- ⊙ Any funds received by District will need to fund reopening costs including testing

Key Findings for Cases and Outbreak Investigations in K-12 Settings (K-12 Schools, Distancing Learning Programs, Before or Afterschool Programs, Youth Athletics, and other Youth Programs)

- Most reports of cases in schools were for single cases only. Only a very small number of reports involved two or more cases.
- Many reported cases from schools have been in staff-only settings (no in-person instruction or students on campus)
- Some of the cases reported by schools involve non-instructional settings (i.e. athletics, before or afterschool care, etc)
- Transmission between children has been rare, as has transmission from children to teachers

Research

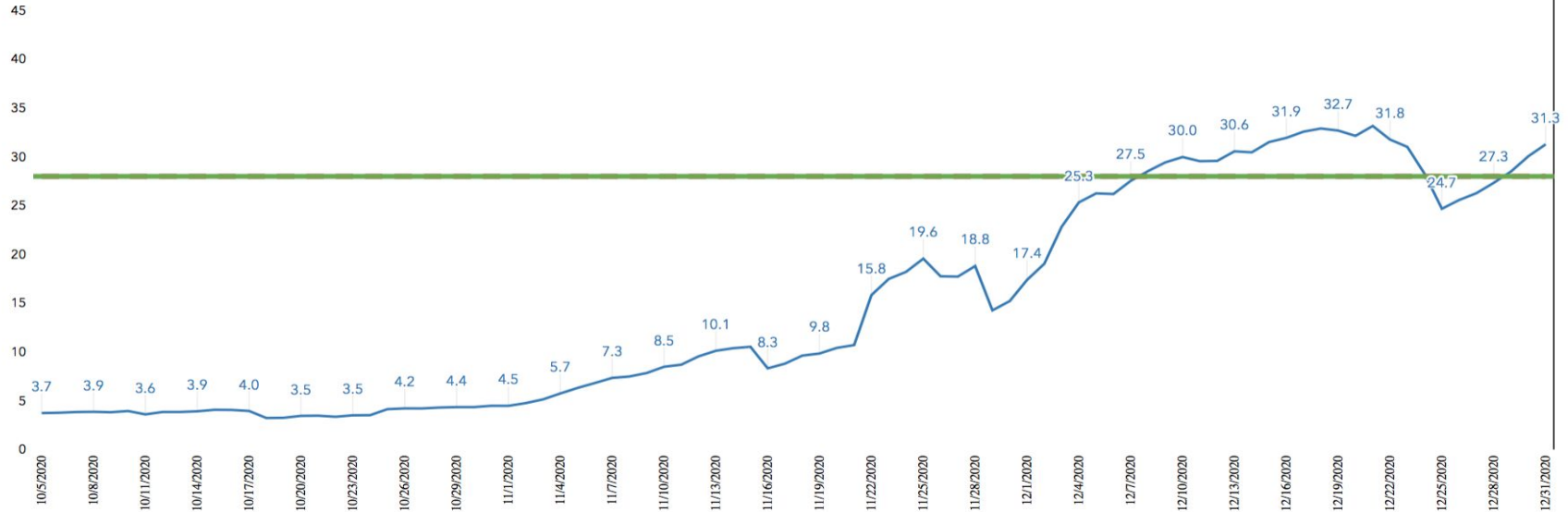
- ⊙ In epidemiological studies globally and nationally, the evidence suggests that children seem to get COVID-19 less frequently than adults (antibody tests)
- ⊙ Children most often get COVID from a household contact
- ⊙ Transmission among or from students is uncommon

Current Reopening Plan

Grade	Initial Student COVID Testing	Return Date
K-2, 6-8 Cohort A	Week of Jan.19	January 25
3-5, 6-8 Cohort B	Week of Jan. 25	February 1

- **Modified student schedules from January 14 - 22 for teacher preparation, planning, and facility set-up.**

Recommendation

- ⦿ **Authorize reopening as previously presented, if state/county metric is met.**
 - ⦿ Final data point for January 25th reopening on January 19th.
- ⦿ If the newly anticipated county guidelines go contrary to the State, the board would meet and re-evaluate.
- ⦿ If the metric is not met on Jan. 19th, the District will continue weekly assessment until metric is met.
- ⦿ Once the metric is met as reported each Tuesday by the State, K-2 and Middle School "Cohort A" will return the following Monday.
