- Expectations are high
- Opportunities for success are great

- Patience and flexibility are required
- Situational awareness on COVID-19 is critical

Open for SDC And RSP Students



Preschool-12th Grade Special Day Classes (SDCs)

- Opened for in-person instruction on October 26, 2020.
 - Related services are also being provided in-person.
-

K-3rd Resource Specialist Programs (RSPs)

- Opened for in-person instruction on November 2, 2020.
 - Related services must continue to be through a distance learning model due to cohort restrictions.
 - K-2 students who join their general education cohorts will need to return to distance learning RSP services due to cohort restrictions.

4th-6th Grade RSP

- Finalizing plans for in-person instruction. MOU with LCTA was signed on November 11, 2020. Anticipated reopening is February 1, 2021.

7th-12th Grade RSP

- Access to pods for in-person structure/support based on priority level.
- Continued distance learning.

Protocols for Reopening TK-2:

- Daily Health Screener - Most Important Part of the Day!
- Reinforcing Behaviors: Wear a Mask, Stay Socially Distanced, Stay with your Cohort, Wash your Hands Frequently
- No Visitors on Campus
- Carline and Gate: Screener Checks, Temperature Taking, Hand Sanitizer
- Paraprofessionals Walk to Classrooms or Playground - Paws Help Us to Stay 6' Apart
- Classroom Arrangements
- Recess Zones
- Dismissal Procedures
- Cleaning Routines

Hybrid and VLA

- Some Hybrid schedule families were not ready to return to in-person instruction
- Maintained classroom ratios, except three Kinder virtual cohorts at 16:1
- Did not backfill the Hybrid spaces
- Families can return students to Hybrid on January 11 or on March 1, 2021
- If we encounter school closures, students will continue or resume distance learning with the teachers and cohorts assigned on the date the closures begin
- We will remain open for in-person instruction in January, but monitor and respond as necessary

TK-2 Reopening



Top 5 Essentials for a Successful TK-2 Reopening - Building Confidence:

1. Conduct Daily Prescreener - **Stay home** if you have fever (100.4 or higher), new cough, diarrhea, vomiting or if you have been in contact with someone with a positive COVID diagnosis
2. Wear Your Mask
3. Maintain Social Distance - the Paws and Dots are our new campus guides
4. Wash Your Hands and Follow Bathroom Protocols
5. Stay with your classroom cohort

LCUSD Next Steps Grade 3 Reopening



- 3rd Grade hybrid schedule students may be brought back as a part of the 25% high-need, high-risk student population
- Need COVID surge numbers to lower and stabilize
- Classrooms are being prepared
- Protocols are in place
- Ratios meet current limits
- MOU Requirements Set
- Target date is mid-February

LCUSD Next Steps Grades 4-6 Reopening



- Need DPH to expand TK-2 Waiver and cohort ratio numbers
- Following DPH's Waiver Expansion - File Waiver Notification (1-2 day process)
- Rooms being prepared for reopening early to mid-March
- MOU Requirements Set
- DPH has indicated Vaccines for School Personnel available Early February

LCUSD Next Steps Elementary Reopening Limitations



- Social Distancing will be required
- Ratios and AM/PM schedule require that the VLA remain virtual (families committed to VLA for full year)
- Some Hybrid families will not want to return to in-person instruction
- After full Hybrid reopening, principals will assess the number of open seats by classroom per grade level
- Could consider 3rd Trimester “lottery” for VLA families wanting in-person instruction

California's Safe Schools For All Plan 12/30/2020 Governor's Slides



- California's youngest and most disproportionately impacted students will be prioritized.
- California's phased approach will:
 - Begin with in-person learning for K-6, special education, and populations disproportionately impacted by COVID-19
 - Support all communities to be on track for safe in-person learning by early Spring 2021
 - Distance learning will remain an option for parents and students

California's Safe Schools For All Plan 12/30/2020 Governor's Slides



- Funding to support safe reopening (\$450 per student to districts offering in-person instruction, weighted for unduplicated pupils)
- Safety and Mitigation (Testing, PPE, Contact Tracing, Vaccinations)
- Oversight and Assistance (hands on support to help schools develop COVID-19 Safety Plans)
- Transparency and Accountability (state dashboard will enable all Californians to see their school's reopening status, funding, and in-school transmissions)

LCHS 7-12 Pods High-Need High-Risk



Learning Pod Goals:

- Provide structure at school
- Reduce distractions in the learning and work environment
- Increase assignment completion
- Work to improve grades
- Currently operating 9 pods and serving 90 7-12 students

LCHS 7-12 Pods High-Need High-Risk



7-12 Learning Pods

- School Hours
 - Start Time - 8:25/8:30 am
 - End Time - to 1:35/1:15 pm
- Substitute teachers supervise while students participate in their distance learning classes
- Stable non-mixing cohorts of 14 total people
- Students wear masks at all times, except when eating in their assigned area
- Break will be taken in the classroom
- Social distancing will be maintained in class

LCUSD Next Steps for 7-12 Reopening



- There will be no 7-12 Reopening in the most restrictive Purple Tier
- We need guidelines regarding cohort sizes and allowable frequency for mixing
- Our planning approach changes based upon these guidelines
- DPH “hinted” cohorts of 60 - 15:1 classes; 4 stable teachers
- Our Principals are “thinking outside the box”
- We recognize the importance for in-person learning and socialization with our 7-12 students
- Set Priorities - Our Class of 2021 is one Priority

LCUSD Next Steps for 7-12 Reopening



- We also recognize the instructional “stakes” are higher for 9-12 students
- We have created over 40 schedules - we will revisit these and continue to generate new ideas
- Our 7-12 Reopening Committee meets again on Tuesday, January 26, and we will assess all priorities with the Committee
- We are required to negotiate the effects of Working Conditions for 7-12 Reopening
- We remain hopeful for the vaccine in early February

Update On COVID-19 Testing Plan



- Testing Plan is required by the Reopening Protocols
- Implemented an optional testing opportunity for staff (since early November)
- Testing offered approximately every two weeks
- Four rounds of testing at all school sites to-date
- Through 12/31 - No cost to staff
- Working with ASCIP to mitigate Blue Shield costs after 12/31
- Now averaging about 100 tests per site
