Our staff training focuses on techniques to improve student achievement and is conducted in collaboration with Cambridge and Chesnut Continuation High Schools. The staff attends professional conferences in their subject areas in order to gain a better working knowledge in both lesson delivery, and classroom management. The entire Alt Ed staff meets once a month for professional development on issues directly related to the Alt Ed setting.
