# Health and Safety

- ▶ **Air filtration:**
  - ▶ 1500 HEPA filters as recommended by ASHRAE have been received; vast majority installed with 2 per classroom in classrooms in use or planned for student use and in other used spaces; additional orders made to cover all spaces
  - ▶ MERV 8 filters upgraded to MERV 11 filters throughout District
  - ▶ Thermostat upgrades to begin to include CO2 monitors
- ▶ **Hand-sanitizer dispensers:** installed in 99-100% of classrooms and work areas; some still waiting on sanitizing gel which is back-ordered but expected before end of February
- ▶ **Hand-washing stations:** some installations have been made outdoors with all locations identified; may need to contract out rest of installations
- ▶ **Water-bottle fillers:** outside locations identified and fillers have been ordered; may need to contract out installations
- ▶ **Vape Detectors** in all restrooms serving 6<sup>th</sup>-8<sup>th</sup> grade students: installed by end of March 2021
