


- ▶ Physical Distancing:
 - ▶ General (spacing in classrooms*, when practicable)
 - ▶ Entrance, Egress & Movement Within the School
 - ▶ Bus Transportation (masks required, limited space)
 - ▶ Classroom Settings / Seating Charts
 - ▶ Non-Classroom Settings
 - ▶ Co- & Extra-Curricular Activities
 - ▶ School Events




▶ Hygiene Measures:

- ▶ Handwashing & hand sanitizing
- ▶ Minimize sharing of equipment or supplies
- ▶ Class-by-Class desk hygiene
- ▶ Face coverings:
 - ▶ Required - All 7th - 12th grade students
 - ▶ Required - All adults on school campus
 - ▶ *Some exemptions (special needs students or those with health/breathing issues)*

SCREEN ALL STUDENTS FOR POTENTIAL COVID-19 SYMPTOMS OR EXPOSURE


General Symptoms

High-Risk: Red Flag Symptoms


- Fever 100.4°F(38°C) or higher
- Sore throat
- Cough
- Congestion/runny nose
- Headache
- Difficulty Breathing
- Nausea/Vomiting/Diarrhea
- Fatigue/muscle aches or body aches
- Loss of taste/smell

Exposure to COVID-19 Positive Person?

Close Contact = Less than 6 feet, 15 minutes or Longer



This care pathway was designed to assist school personnel and is not intended to replace the clinician's judgment or establish a protocol for all patients with a particular condition. Diagnosis and treatment should be done under the close supervision of a qualified health care provider.



Daily Checklist for Families

Monitor your student for the following symptoms and keep your student home if ANY of the following are true:


- If your student experiences ONE of the following symptoms:
 - Fever (100.4°/38°C or greater) **(Please check your student's temperature the night before school and keep home the next day if running a fever.)**
 - Cough
 - Shortness of breath or difficulty breathing
- If your student experiences any of the following symptoms:
 - Fatigue
 - Muscle or body aches
 - Headache
 - New loss of taste or smell
 - Sore throat
 - Congestion or runny nose
 - Nausea or vomiting
 - Diarrhea
- In the past 14 days, has your student had close contact with someone diagnosed with COVID-19?
 If so, please follow all health department/physician ordered quarantine directions.

Students should bring daily:

- Chromebook
- Water Bottle
- Face Coverings


7-12 Reopening Plan: Prevention

- ▶ Cleaning & Disinfection and Additional Health/Safety Measures:
 - ▶ All sites cleaned thoroughly daily
 - ▶ Deep cleaning every Wednesday
 - ▶ Protective barriers /desk shields installed
 - ▶ Ventilation & opening windows/doors
 - ▶ Disinfecting wipes for end/beginning of class period



7-12 Reopening Plan: Monitoring

- ▶ Health Screenings for Students & Staff
 - ▶ Contactless thermometers will be used when students display symptoms.
 - ▶ On a daily basis before coming to school, Parents/Students and Staff need to self-conduct COVID-19 symptom screening.
 - ▶ *Do not* come to school if you have a temp above 100.4 degrees, cough, shortness of breath or respiratory illness.



7-12 Reopening Plan: Monitoring

- ▶ COVID Testing of Students & Staff
 - ▶ MCS provides testing weekly for staff (voluntary).
 - ▶ Parents of symptomatic students will be contacted and testing will be recommended.
 - ▶ ***MCS does not offer or conduct COVID testing for students.***



7-12 Reopening Plan: Monitoring

▶ What happens when there are COVID Cases:

▶ *Negative test results:*

Individual stays in quarantine 10 days after initial exposure.

▶ *Positive test results:*

Individual can return to school campus 10 days after symptoms first appeared AND at least 24 hours with NO fever or use of fever reducing medications, AND improvement of symptoms. *County Public Health will also provide MCS and individuals with guidance on quarantine & contact tracing.*



7-12 Reopening Plan: Monitoring

- ▶ Identification & Tracing of Contacts
 - ▶ Close contact is defined as within 6 feet for 15 or more minutes or direct physical contact (with or without a mask).
 - ▶ Working with County Public Health, contacts will be traced and notified to quarantine. Confidentiality is maintained.



7-12 Reopening Plan: Monitoring

When to Close a Class



With public health, consider closing if one or more students or staff members is confirmed to have COVID-19

When to Close a School



With public health, consider closing if multiple "cohorts" or classes have confirmed cases OR 5% of all students/staff have confirmed cases

When to Close the District



25% or more of schools in a district have closed due to COVID-19.



When to Re-Open

Schools may typically reopen after 10 days and the following have occurred:

- Cleaning and disinfection
- Public health investigation
- Consultation with the local public health department



7-12 Reopening Plan: Monitoring

- ▶ MCS site and district administration communicates with students, staff, and parents about cases and exposures at the school within 24hrs of notification, consistent with health privacy requirements to maintain confidentiality.
- ▶ Communication will be provided in families home preferred language as necessary.



COVID-19 Potential Response Scenarios in a School Setting
Measures to Take When a Student or Staff Member has Symptoms, is a Contact of Someone Infected, or is Diagnosed with COVID-19

*A contact is defined as a person who is <6 feet from a case for >15 minutes. In some school situations, it may be difficult to determine whether individuals have met this criterion and an entire cohort, classroom, or other group may need to be considered exposed, particularly if people have spent time together indoors.

 - ▶ In-Person Learning
 - ▶ Distance Learning
 - ▶ Distance/Remote Learning as an option

- ▶ Site cohorts will be determined by grade level, alpha order.
- ▶ Sites will also consider family details/siblings.
- ▶ Distance learning 100% at home will still be offered for parents who choose that option.

7-12 Reopening Plan: Hybrid

Per State & County Public Health (as of 1/14/21), Stanislaus County must be in “red tier” for 5 consecutive days before we can reopen grades 7-12 in a hybrid, cohort model.





Stanislaus County


As of 2/16/21:

- *Case rate (adjusted) = 31.3 cases per 100,000*
- *9.0% = 7-day positivity rate*
- *Data updated every Tuesday by the CDPH.*



Current tier assignments as of February 16, 2021

Tier assignments may occur any day of the week and may occur more than once a week. Select a county to see what region it's in.



7-12 Reopening Plan: Timeline

- ▶ Previous CDPH guidance stated 7-12 schools could be reopened after 14-days in the red tier.
- ▶ New CDPH guidance issued on January 14, 2021 allows for reopening of 7-12 schools in a hybrid cohort model after 5-days in the red tier.
- ▶ County Public Health estimates we may reach the Red tier around mid-March.



7-12 Reopening Plan: Timeline

- ▶ Previous recommendation was a staggered start for 7-8 and 9-12 schools.
- ▶ Updated recommendation aligns 7-12 schools to start on same date in a hybrid model.
- ▶ Date TBD - This depends on when Stanislaus County reaches and sustains the Red tier for 5 days.



Next Steps

- ▶ Continue working with our labor partners
- ▶ Verify all the necessary supplies and materials are in place
- ▶ Continue development of support for students, parents, and staff
- ▶ Ongoing coordination of reopening plan implementation with secondary school sites
- ▶ Communicate with 7-12 families

Recommendation / Action:

- ▶ Open 7-12 schools in a hybrid 2-day per week model in alignment with current CDPH or County Public Health guidance.
- ▶ Current guidance states 7-12 reopening after Stanislaus County reaches 5 consecutive days in the red tier (open on 6th day in red).
