1. The "Scope of Services" of the above referenced Agreement is hereby modified as follows:
(For "Scope of Additional Services" refer to the Exhibit A (HMC Architects' Proposal dated June 1, 2020),
which is for reference only):

1. Additional Services Request #05 for A/E Services to provide a 3D survey of the gravel grindings pile so as to provide a hyper-accurate take off of material to remain for the new school site work versus quantity to be off hauled.

- a. Site topo survey by BKF of just the gravel pile.**
- b. Deliverables are a DRAFT and FINAL 3 dimensional plan and calculations.**
- c. Coordination of BKF and 2 District meetings (during the weekly conference call).**

"Compensation and Payment" of our Agreement approved by the BOT 06/06/19 is hereby modified to allow for the additional fees required to implement the above changes. The present fee of architectural services of \$736,726.33 is hereby increased by a not-to-exceed fee of **\$10,000.00**, for a fixed fee of **\$746,726.33** for the architectural services.

The new contract amount is **\$746,726.33**.

The contract completion date of the project after receiving the Amendment is to remain the same.

All other conditions of our Agreement (and subsequent Amendment(s) set forth above) remain in full force and effect as originally stated.
