SUBJECT: COUNTY OF SANTA CLARA TREASURY INVESTMENT PORTFOLIO STATUS

RECOMMENDATION

Receive and file the December 31, 2020 Detailed Investment Portfolio Listing.

DISCUSSION

In compliance with the State of California Government Code as amended by Chapters 783 and 784, Statutes of 1995 and in compliance with County Policy, the Santa Clara County Treasury Investment Portfolio Report as of December 31, 2020 is submitted for your review and acceptance.

The attached detailed investment reports list each investment of the County Treasury Pool, as well as individual reports for specific investment funds that each school district or special district has in the County Treasury. The reports include the respective purchase and maturity dates, par value, amortized cost, market value, and yield to maturity for each investment.

A summary of market value versus cost is provided below for Commingled Investments of the County Pool.

The yield of the Pool on December 31, 2020 was .92%. As a comparison, on December 31, 2020 the yield of a 6-month Treasury Bill was .08%. A two-year Treasury Note was .12%. The State of California Local Agency Investment Fund (LAIF) yield was .54%.

Attached with the current investment strategy is a schedule that lists the average weighted maturities and yield for the Commingled Treasury Pool. Charts outlining investment concentration and distribution of bond maturities are provided for the Pool. Also included is a chart showing the one-year history of the Pool along with interest rates offered by selected comparable instruments.

Securities are purchased with the expectation that they will generally be held to maturity, hence unrealized gains or losses are not reflected in the yield calculations.

The market values of Pool securities were taken from pricing services provided by Bank of New York Mellon, Bloomberg Analytics, dealer quotes, and an independent pricing service.

A combination of securities maturing, new revenues, and tax receipts will adequately cover the anticipated cash flow needs for the next six months. Cash flows are continually monitored and are considered paramount in the selection of securities purchased for the Pool.

*Yield to maturity (YTM) is the rate of return paid on a bond, note, or other fixed income security if the investor buys and holds it to its maturity date and if the coupon interest paid over the life of the bond is reinvested at the same rate as the coupon rate. The calculation for YTM is based on the coupon rate, length of time to maturity, and market price at time of purchase.

Yield is a snapshot measure of the yield of the portfolio on the day it was measured based on the current portfolio holdings on that day. This is not a measure of total return, and is not intended to be, since it does not factor in unrealized capital gains and losses and reinvestment rates are dependent upon interest rate changes

Portfolio Strategy

December 31, 2020

The U.S. economy slowed markedly in the final three months of 2020 after record third-quarter growth while the U.S. labor market lost jobs in December for the first time in eight months. Economic growth moderated to a 4 percent annualized rate in the fourth quarter while real gross domestic product (GDP) for the year declined by 2.5 percent. Surging coronavirus infections prompted mandatory closure of parts of the service economy, constraining the domestic recovery and limiting Americans' ability and willingness to spend. Pandemic-sensitive sectors like leisure and hospitality will likely remain depressed until widespread vaccinations allow for unfettered spending on services. It is unclear when the economy will be able to reopen more broadly, but when it does, economists expect high savings, pent-up demand and additional fiscal relief will bolster growth.

The dismal December jobs report strengthened arguments for another sizeable pandemic relief package. President Joe Biden intends to enact a \$1.9 trillion relief plan most likely without a bipartisan support. Many Republicans prefer to hold off on more assistance and wait for the \$900 billion aid package Congress already approved in late December 2020 to filter through the economy.

Despite a near collapse of the economy in early 2020, certain sectors have remained surprisingly resilient. Robust home sales generated support for construction. Companies continued to invest in equipment, sustaining a manufacturing rebound, while at the same time factories boosted output to replenish lean inventories. Most noteworthy, U.S. domestic equity markets generated record breaking returns in 2020.

U.S. labor market generated disappointingly modest job growth for the month of December. Private payrolls increased by only 6,000 in December, primarily attributable to job cuts in retail trade, transportation, warehousing and in leisure and hospitality, while other industries only experienced modest gains. In the latter half of the quarter, restrictions on activity and businesses were imposed to stem the surge in virus cases and due to fears of more contagious virus variants.

Federal Reserve Bank (Fed) policy makers have signaled that monetary policy would remain very supportive of the economy with emphasis on full employment and expect to hold interest rates near zero at least through 2023. With no significant threat of inflation, this policy position is tenable. Throughout the pandemic there has been very little inflationary pressure, and December was no exception. The index of consumer prices that the policy makers officially uses for its target rose a mere 1.3 percent in December from a year earlier. The core price index, which excludes more-volatile food and energy costs, increased 1.5 percent.

Portfolio Strategy

The Fed's unprecedented emergency measures, including slashing benchmark rates to zero, to combat the economic impact of the pandemic have strongly advantaged large corporations, the wealthiest and those whose wealth is in the form of financial assets. Fed policy resulted in U.S. stocks surging to record highs in the aftermath of the outbreak. Fueled by historically low interest rates, the median price of a single-family home climbed 14.9 percent in the fourth quarter, the biggest price surge since 1990, according to the National Association of Realtors. Mortgage re-financings have accelerated to the fastest in nearly two decades, according to data from Fannie Mae, allowing millions of borrowers to cut their monthly payments.

Fed policy makers have regularly acknowledged that monetary policy is not a perfect tool. Many do not have easy access to credit and financial markets. Distributing aid to smaller firms and low-income workers has not been particularly effective. Delays in the delivery of assistance, as well as confusion around rules and eligibility criteria, hindered many of those programs.

The portfolio strategy continues to focus on the:

- (1) acquisition of high-quality issuers;
- (2) identifying and selecting bonds with attractive valuations;
- (3) appropriately sizing the liquidity portion of the portfolio to ensure adequate cash for near term obligations; and
- (4) ensuring that monies targeted for longer term investments are deployed in vehicles with favorable risk-adjusted yields.

Portfolio Liquidity Adequacy, Review, and Monitoring

Yield and Weighted Average Maturity

The yield of the Commingled Pool is 0.92 and the weighted average life is 569 days.

Liquidity Adequacy

The County Treasurer believes the Commingled Pool contains sufficient cash flow from liquid and maturing securities, bank deposits and incoming cash to meet the next six months of expected expenditures.

Review and Monitoring

FHN Financial Main Street Advisors, the County's investment advisor, currently monitors the Treasury Department's investment activities.

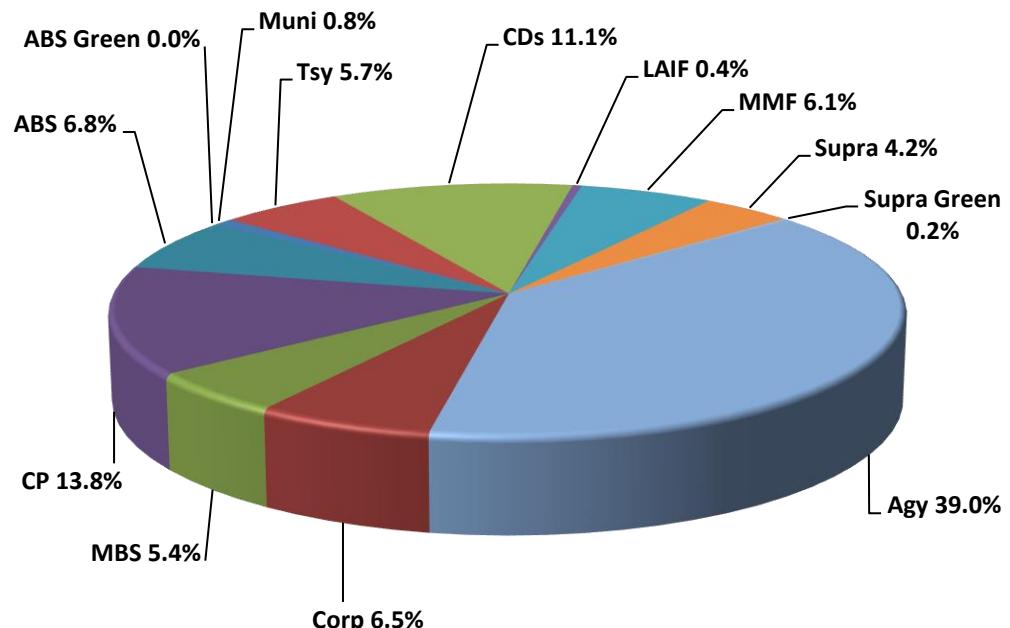

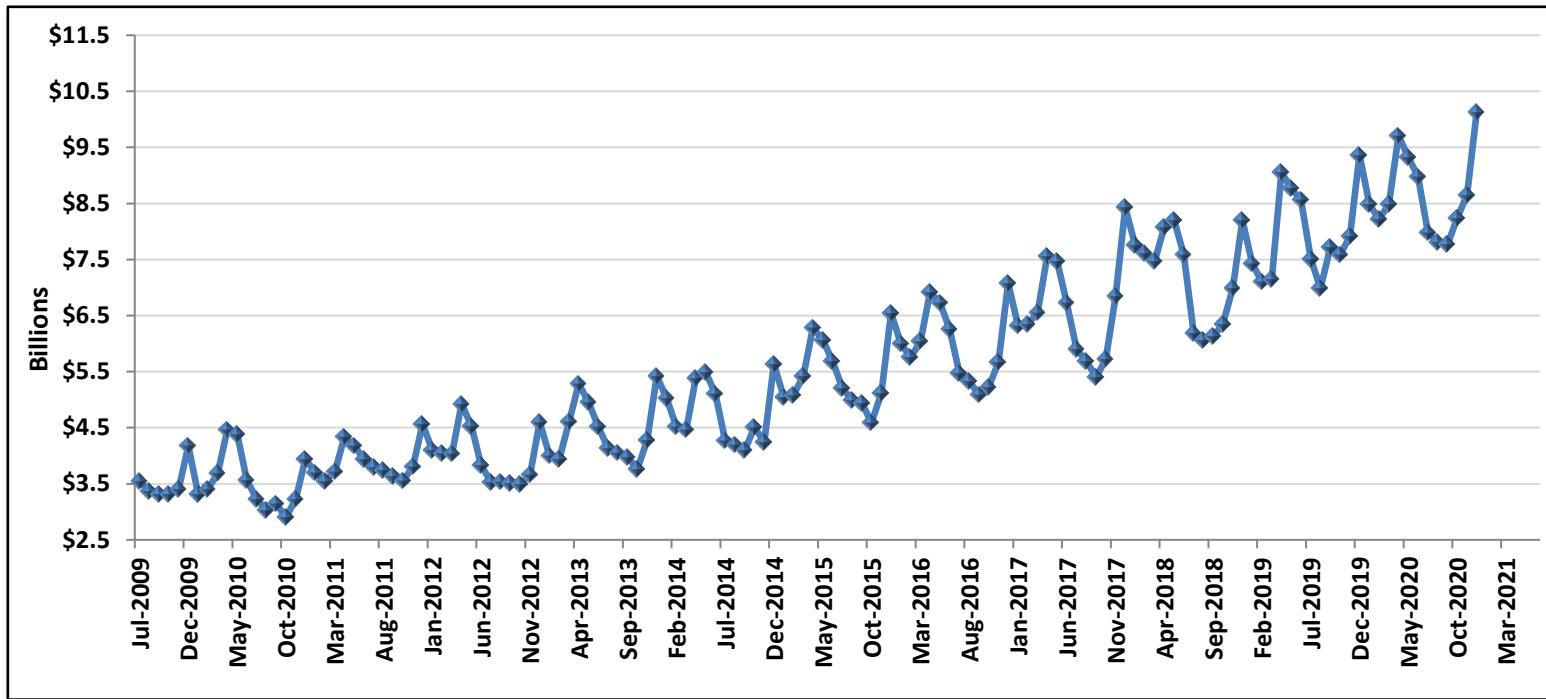

Allocation by Security Types

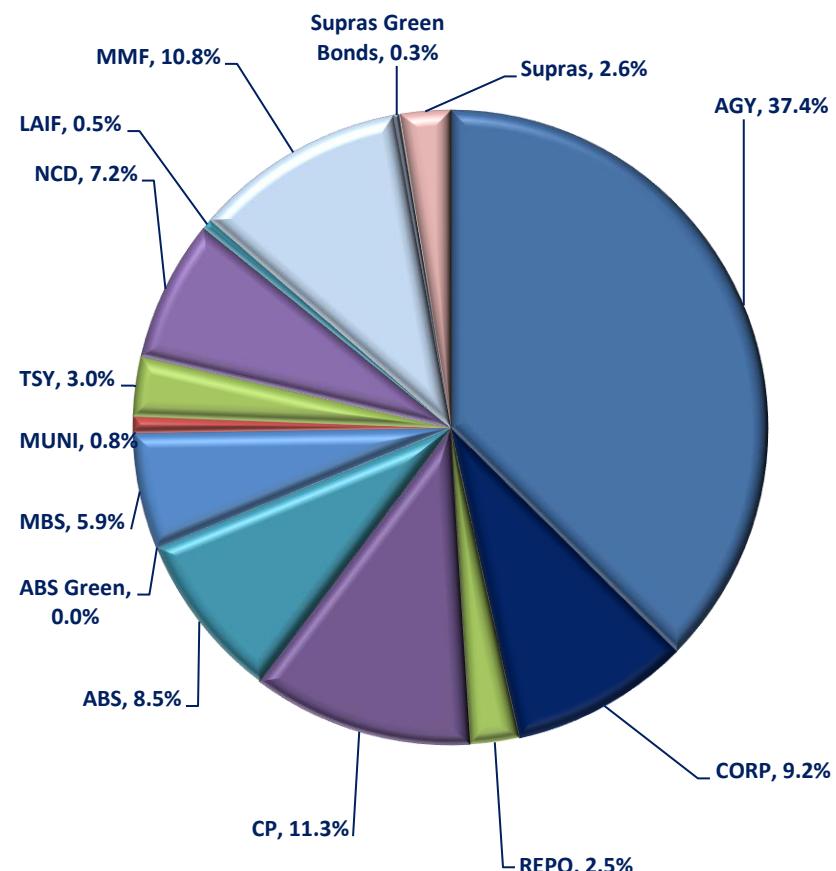

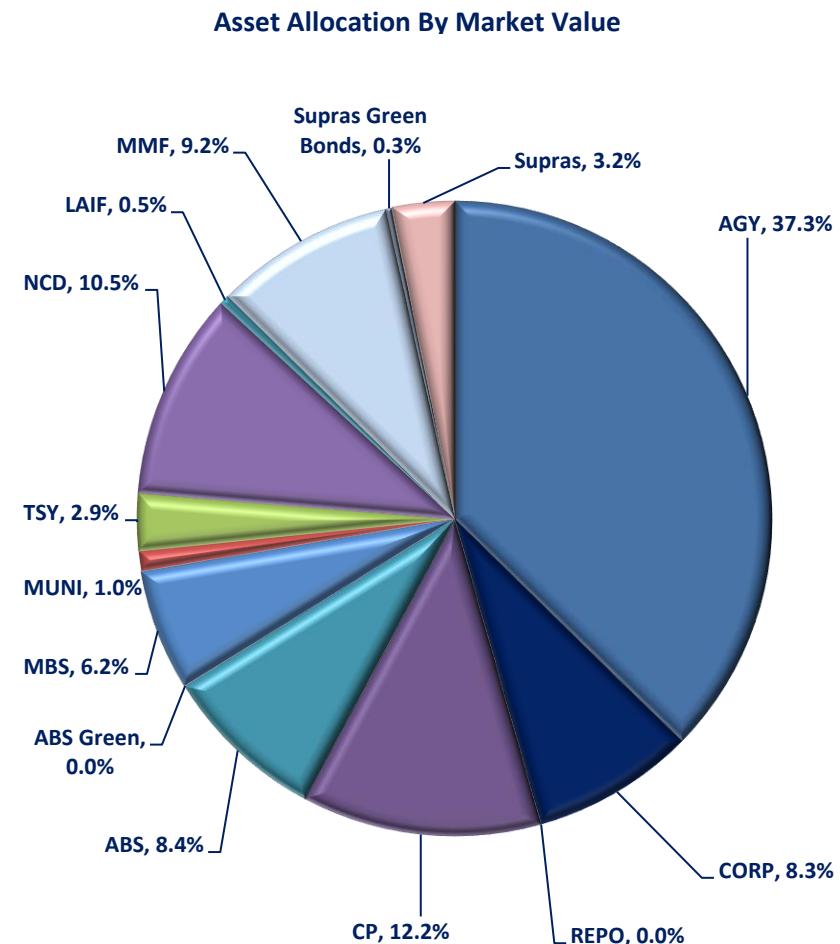
