I. Welcome and Introductions (5 minutes)

Associate Superintendent Bryant welcomed the attendees and expressed appreciation for their on-going commitment to the students of DJUSD. He then asked Superintendent Roberson to share the Focus and Priorities of the LCAP.

II. Review of the Goal for the Evening (15 minutes):

Associate Superintendent Bryant reviewed the goals for the meeting and reviewed the various documents in the packets for the group. He also reviewed progress towards the goals in the LCAP with a short presentation.

Brief discussion about counseling in particular as a priority and a question about PTA funding positions at sites

This was followed by an update presentation by Jennifer Chapman and LaTosha Adams who conducted over 100 individual student surveys for the LCAP advisory process. Their presentation addressed trends from student responses to survey (too much homework, desire for closer relationships with teachers, etc).

III. Review community feedback and Identify Trends (50):

After the presentation, the group was divided into small groups to consider potential district needs on a list provided to the groups. Associate Superintendent Bryant explained that the items came through different avenues to this group. Some came through administrative recommendations such as the Administrative Leadership Team, Principals' Meetings, or the Superintendent's Cabinet. Others came through the Community Forums and Community Survey results the group had previously reviewed.

The groups were asked to identify if the needs were Essential, Beneficial, or Not Necessary at This Time. Groups spent approximately 40 minutes working on this activity. Each group kept notes on chart paper as they worked. Associate Superintendent Bryant brought the group back together at approximately 7:50 and asked each group to find a reasonable stopping place so that they can continue the work at the next meeting. At 8:00 the meeting was adjourned.
