## By collaborating with great partners, especially BGCP, we offered students a rich, strong program

- **BGCP:** deep, embedded partnership before & during the program (hiring, enrollment, student & family engagement, operations & safety, high quality enrichment)
- **Big Lift (kinder):** enrichment, classroom facilitators, kinder-specific curriculum and materials
- **TFA / TNTP:** TFA Corps Members to lower student/teacher ratios, chance for mentor teachers to develop others



We are looking at different ways to measure impact

Quantitative data

- Academic impact: BOY and EOY using existing assessments
- Engagement & attendance: BGCP & District will be tracking attendance
- Survey data on engagement & impact of the program
  - BGCP will survey students and staff during the program
  - District will use Panorama to survey parents
  - We'd share the data to evaluate impact of the program

Qualitative data: observations, conversations, etc.

- BGCP UD's and District site admins will be observing, share reflections on how it's going

# We jump-started learning for almost one third of our students during a supercharged summer program!

- >500 students attended
- 3 school sites (CCRMS, Costaño, Belle Haven)
- Rising kindergarteners through 8th graders
- Support for students with special needs through extended school year

## Joyful engaging learning

- Hands on learning
- Joy and excited to be at school
- Learning happens when kids are having fun

## Know our students well

- Social emotional needs

## Rigorous learning, NOT remediation

- Response to disruptions is sometimes “jam kids full of content”
- Research showing that is NOT the best way to help kids propel forward
- Both/and: joyful relationships / knowing kids AND rigorous learning

Students had five weeks of fun, engaging, hands-on learning and enrichment



Our goals for the summer

- Joyful, engaging, hands- on learning & enrichment... in person!
- Know our students well
- Rigorous learning, not remediation

## ...and we did it safely



- Continued our spring safety protocols
- BGCP conducted weekly COVID testing
  - >400 tests administered per week (~85% of students participated)
  - No positive cases from our tests
  - Responded quickly to a potential case of exposure w/rapid testing
- We feel confident we are ready for the fall

# We're already planning for next summer

- We're gathering feedback from all stakeholders to evaluate the summer
- In October, we'll update the board on academic impact
- We're created a "playbook" to guide summer programming next year
