

**RESOLUTION OF THE GOVERNING BOARD OF

ADOPTING THE "GANN" LIMIT FOR THE VISTA
DEL MAR UNION SCHOOL DISTRICT
PURSUANT TO GOVERNMENT CODE SECTION
7902.1**

RESOLUTION NO. 2021-22/3

WHEREAS, In November of 1979, the California voters approved Proposition 4, commonly referred to as the Gann Amendment, adding Article XIII-B to the California Constitution; and,

WHEREAS, Proposition 4 established maximum appropriation limitations, commonly referred to today as the “GANN Limits”, for public agencies, including school districts; and,

WHEREAS, the Vista Del Mar Union School District must establish a revised Gann limit for the 2020-2021 fiscal year and a projected Gann Limit for the 2021-2022 fiscal year in accordance with the provisions of Article XIII-B of the California Constitution and the applicable statutory law; and,

NOW, THEREFORE, IT IS HEREBY RESOLVED:

1. That this Governing Board does hereby provide public notice that the attached calculations and documentation of the Gann Limits for the 2020-2021 and the 2021-2022 fiscal years are made in accord with applicable constitutional and statutory law;
2. That this Governing Board does hereby declare that the appropriations in the Unaudited Actuals for 2020-2021 fiscal year and the appropriations projected for the Budget in 2021-2022 fiscal year do not exceed the limitations imposed by Proposition 4;
3. That the Superintendent/Principal provides copies of this resolution along with the appropriate attachments to interested citizens of this District.
4. The Governing Board directs the Superintendent/Principal and District staff to take such other and further actions as necessary to accomplish the intent of this resolution;
