RECOMMENDATION

Receive and file the June 30, 2021 Detailed Investment Portfolio Listing.

DISCUSSION

In compliance with the State of California Government Code as amended by Chapters 783 and 784, Statutes of 1995 and in compliance with County Policy, the Santa Clara County Treasury Investment Portfolio Report as of June 30, 2021 is submitted for your review and acceptance.

The attached detailed investment reports list each investment of the County Treasury Pool, as well as individual reports for specific investment funds that each school district or special district has in the County Treasury. The reports include the respective purchase and maturity dates, par value, amortized cost, market value, and yield to maturity for each investment.

A summary of market value versus cost is provided below for Commingled Investments of the County Pool.

The yield of the Pool on June 30, 2021 was .76%. As a comparison, on June 30, 2021 the yield of a 6-month Treasury Bill was .05%. A two-year Treasury Note was .25%. The State of California Local Agency Investment Fund (LAIF) yield was .26%.

Attached with the current investment strategy is a schedule that lists the average weighted maturities and yield for the Commingled Investment Pool. Charts outlining investment concentration and distribution of bond maturities are provided for the Pool. Also included is a chart showing the one-year history of the Pool along with interest rates offered by selected comparable instruments.

Securities are purchased with the expectation that they will generally be held to maturity, hence unrealized gains or losses are not reflected in the yield calculations.

The market values of Pool securities were taken from pricing services provided by Bank of New York Mellon, Bloomberg Analytics, dealer quotes, and an independent pricing service.

A combination of maturing securities, new revenues, and tax receipts will adequately cover the anticipated cash flow needs for the next six months. Cash flows are continually monitored and are considered paramount in the selection of securities purchased for the Pool.

Portfolio Strategy

Gross domestic product (GDP), the broadest measure of U.S. goods and services produced, grew at 6.5 percent annual rate in the second quarter, just slightly higher than the 6.3 percent growth rate in the first three months of the year. Progress on vaccinations which led to a reopening of the economy, robust consumer spending and accommodative monetary and fiscal policy were all critical factors fueling the economy's expansion. Personal consumption which exceeded forecasts posted an annualized 11.8 percent gain in the second quarter, the second largest gain since 1952. Despite solid recovery progress, effects of the Covid-19 pandemic continue to weigh on the U.S. economy. Employment levels remains well below pre-pandemic levels. The unemployment rate stood at 5.9 percent as of June 30th, well above the 3.5 percent reached in February 2020, just prior to the pandemic. Furthermore, the level of employment as measured by the Labor Department's household survey is still 6.76 million jobs short of what it was before the onset of the virus.

Demand for goods and services is robust. Strong consumer balance sheets, pent-up demand particularly for activities like eating out and traveling and robust private investment which includes both capital spending and housing are underpinning demand and rapid acceleration in consumer spending. Owing partly to government stimulus checks, spending on goods has already exceeded pre-pandemic levels. Recently, outlays have increasingly shifted to the pandemic-battered service sector. Purchases of goods and services increased in June by 1 percent from a month earlier, following a downwardly revised 0.1 percent drop in May according to the Commerce Department.

Elevated demand paired with supply bottlenecks and capacity constraints are pushing prices higher. Rapid acceleration in demand is outpacing supply in numerous industry niches and is creating an inflation concern for economists who fear rising prices will result from this demand/supply imbalance.

In certain sectors, consumer demand has largely outpaced businesses' ability to hire. To try to lure workers back, many restaurant operators and other hospitality businesses are raising wages, offering signing perks and rethinking scheduling practices to make the work more flexible and predictable. Evidence of wage growth is tangible. The June employment report showed a hefty 2.3 percent increase from the prior month in non-supervisory workers' average hourly earnings in the leisure and hospitality industry. Overall average earnings rose only 0.3 percent last month.

Ample anecdotal evidence underscores the inability of companies to find sufficient workers. The lack of job candidates prevented some firms from increasing output, and less commonly, led some businesses to reduce their hours of operation. Job openings remain at record highs, with businesses reporting 9.2 million available positions in May 2021, which was 2 million more than in February 2020. The current worker shortage is generally attributable to expanded unemployment benefits, limited availability of child care, more retirements than expected, voluntary withdrawal of potential workers from the work place and corona virus concerns.

Surges in demand also have overwhelmed transport hubs including ports, generating logjams and increasing logistics costs. Such supply constraints already have led to an increase in prices of goods including lumber, motor vehicles and appliances. U.S. manufacturing expanded at a softer nevertheless solid pace in the second quarter as producers dealt with persistent bottlenecks and input shortages. Shortages of semi-conductors, key components for in-car touchscreens and other functions like power steering stunted auto sales growth. Global output of new vehicles in the first quarter was down more than 2 million units compared to the same period in 2019.

The personal consumption expenditures price index excluding food and energy costs, considered the preferred inflation gauge for Federal Reserve policy makers, has been trending higher, a reflection of higher prices. The index increased at an annualized rate of 6.1 percent in the second quarter, the largest posted gain since 1983 and a rate well, in excess of the 2 percent inflation goal set by policy makers.

So far, Federal Reserve policy makers have not viewed recent spikes in inflation as a concern. Policy makers contend inflation pressures will dissipate quickly since a substantial portion comes from categories directly affected by the reopening of the economy and pandemic driven shifts in demand. This assessment is underscored by the period ending June 30th, in which 52 percent of price increases from the prior month were restricted to six components; used cars, rental cars, vehicle insurance, lodging, airfares and food away from the home- all sectors worst affected by the pandemic.

Federal Reserve policy makers continue to hold the target range for its benchmark policy rate unchanged at zero to 0.25 percent, where it has been since March 2020. They expect to keep rates near zero until 2023. Policy makers have also pledged to maintain asset purchases at a \$120 billion monthly pace to support financial markets.

The pace of U.S. hiring accelerated in June 2021, with payrolls increasing by the most in 10 months. The gain in payrolls for April and May, although strong, fell below expectations. Demand for labor remains robust as employers struggle to keep pace with strengthened demand from consumers and business. In June, nonfarm payrolls increased by 850,000 last, bolstered by strong job gains in leisure and hospitality. This sector created 343,000 jobs, far outpacing other parts of the economy. June payrolls were also bolstered by a 188,000 gain in government payrolls. State and local government education employment rose about 230,000, boosted by seasonal adjustments to offset the typical declines seen at the end of the school year. The unemployment rate increased slightly to 5.9 percent from 5.6 percent the prior month. The uptick was the result of more workers voluntarily leaving their jobs and an increase in the number of job seekers.

Portfolio Liquidity Adequacy, Review, and Monitoring

Yield and Weighted Average Maturity

The yield of the Commingled Pool is 0.76 and the weighted average life is 615 days.

Liquidity Adequacy

The County Treasurer believes the Commingled Pool contains sufficient cash flow from liquid and maturing securities, bank deposits and incoming cash to meet the next six months of expected expenditures.

Review and Monitoring

FHN Financial Main Street Advisors, the County's investment advisor, currently monitors the Treasury Department's investment activities.

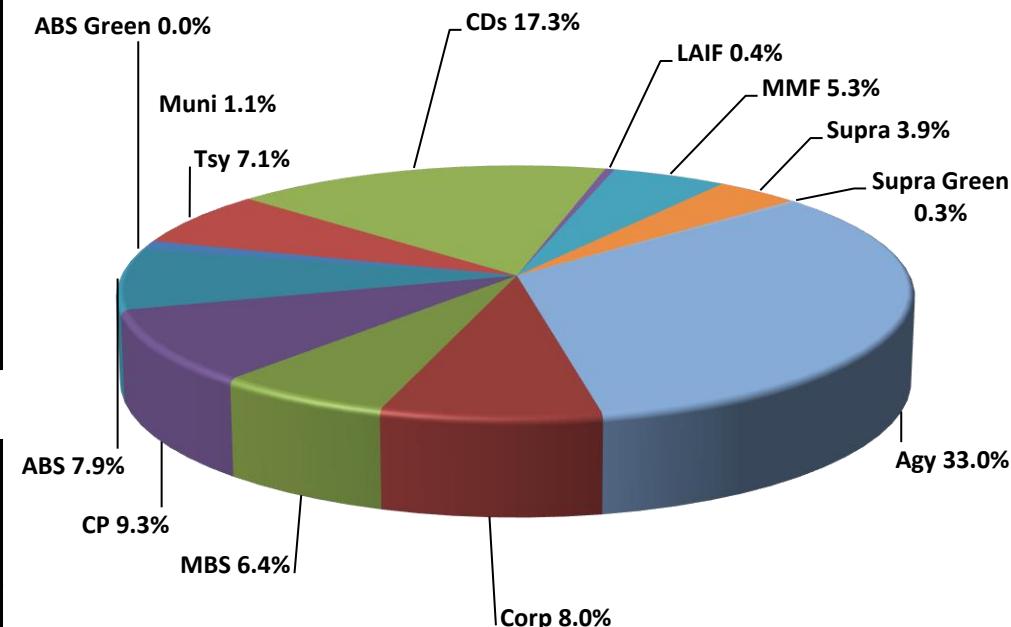

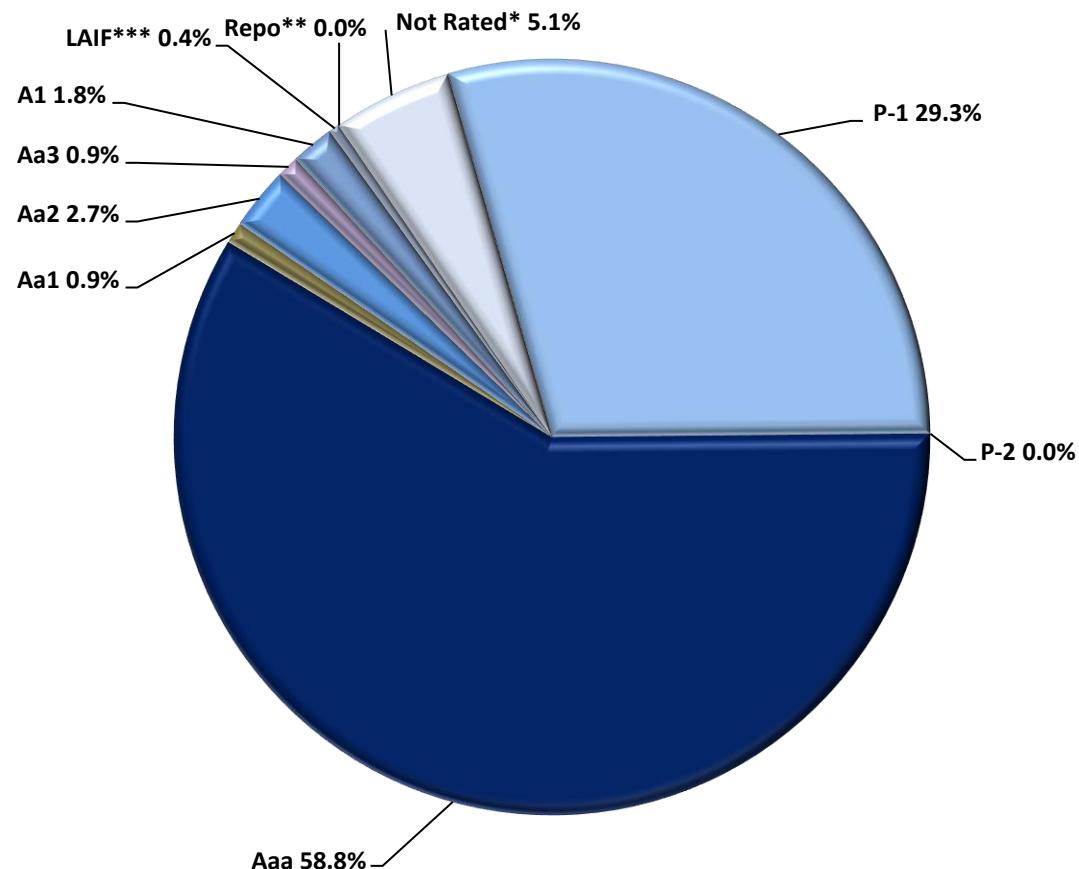

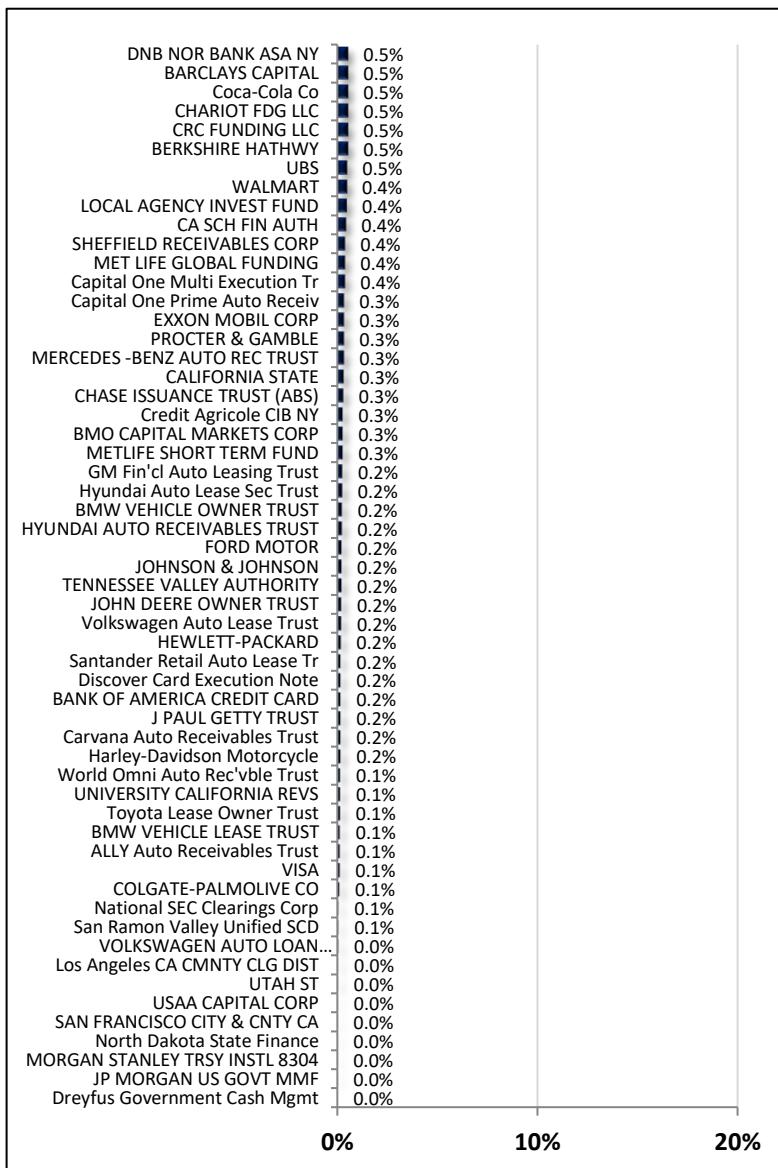

June 30, 2021



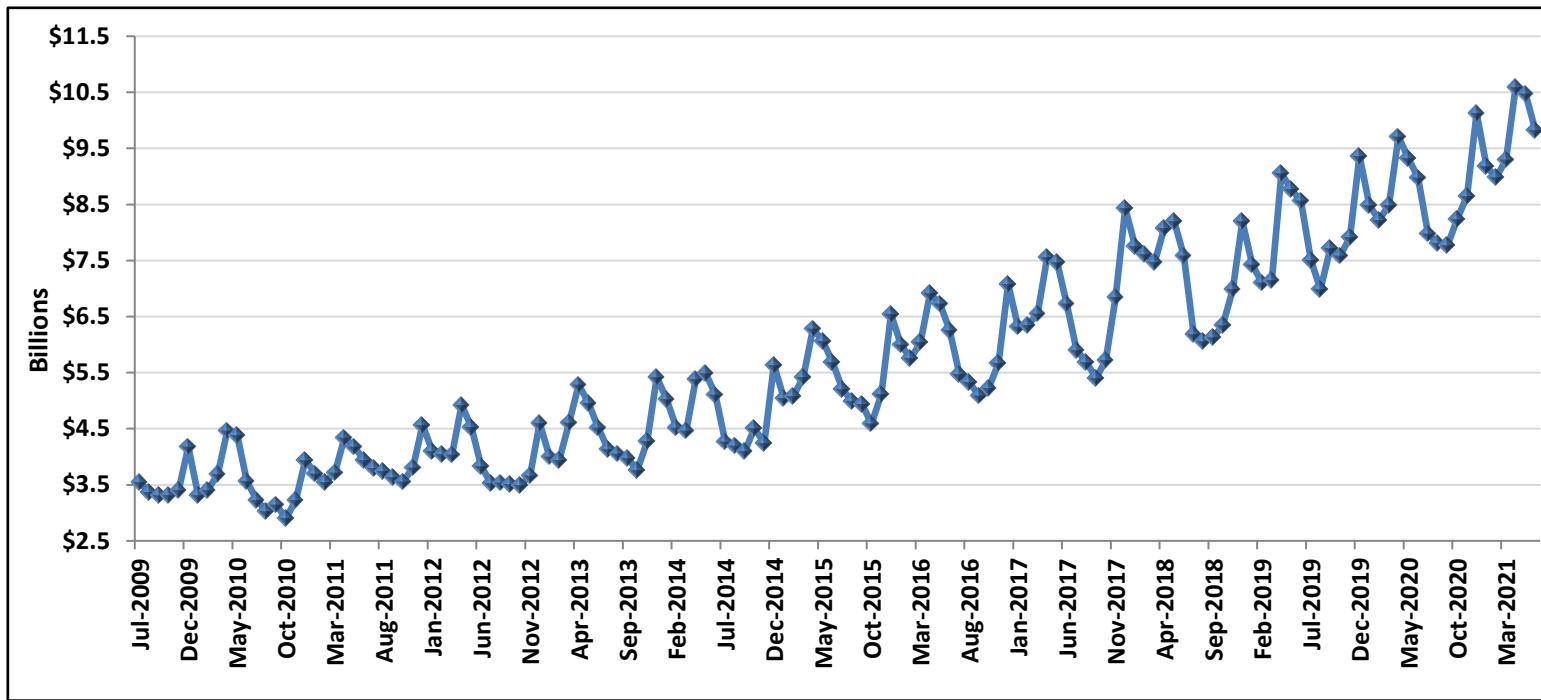

Allocation by Security Types

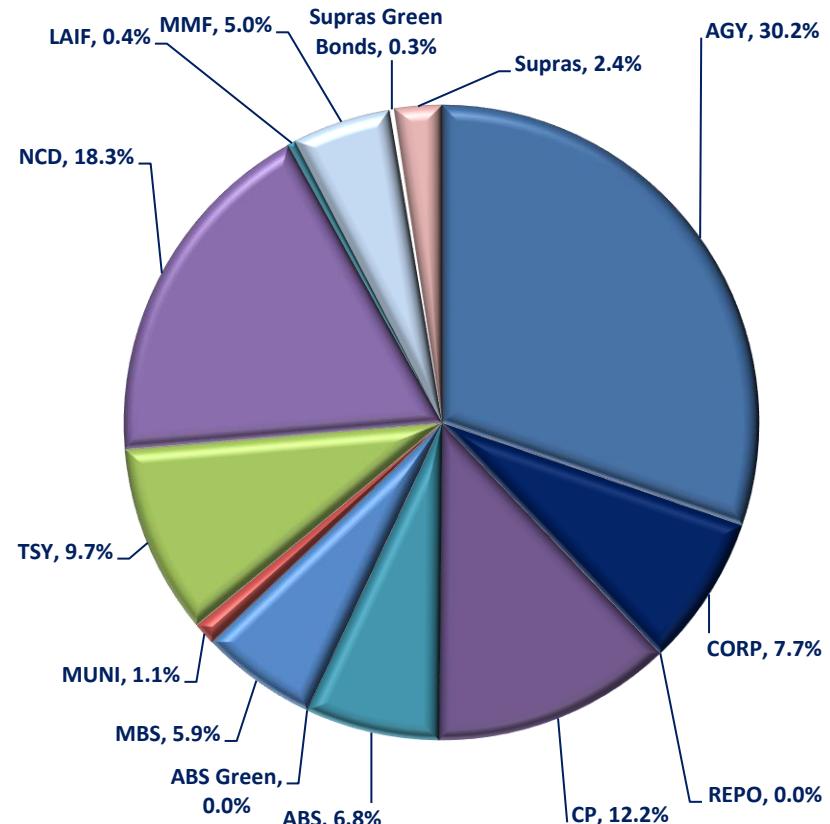

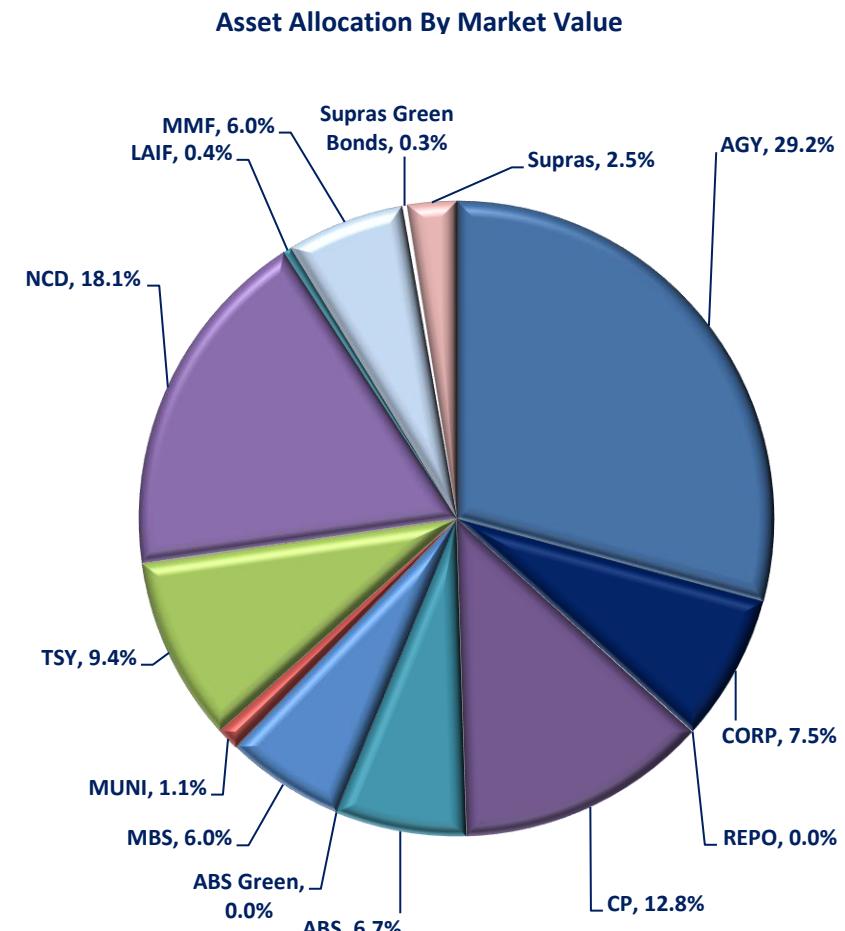
