**Plan Descriptions**

**A description of how the funds will be used to increase or improve services for foster youth, low-income students, and English learners to improve A-G eligibility**

With the following increased and improved services, and in alignment with our 2021-22 to 2023-24 Local Control Accountability Plan (LCAP) and our Expanded Learning - Multi-Tiered System of Support, the Siskiyou Union High School District will improve A-G eligibility for foster youth, low-income, and English learners:

1. Development and implementation of rich and engaging standards based curriculum in all classes.
2. Increased access to A-G approved classes including in the areas of Career and Technical Education (CTE), Fine and Performing Arts (VAPA), Academic Electives, and alternative and/or support level classes.
3. Increase guidance for foster youth, low-income, and English learners to ensure they have an academic plan that includes the achievement of A-G eligibility. Increased guidance will also provide students with specific annual college and career exploration activities so they can develop a clear path and vision of their future options and opportunities.
4. Increase Academic Support for foster youth, low-income, and English learners including the implementation of intensive tutoring to ensure academic success.
5. Increase opportunities for students to credit recover A-G courses so they become A-G eligible.
6. Increase our partnerships with Community Colleges to provide students with access to A-G eligible college courses.

To ensure all students, including foster youth, low-income, and English learners have access to A-G approved courses within our small rural schools, the Siskiyou Union High School District will:

1. Development and implementation of rich and engaging standards based curriculum in all classes.
2. Increased access to A-G approved classes including in the areas of Career and Technical Education (CTE), Fine and Performing Arts (VAPA), Academic Electives, and alternative and/or support level classes.
