12. COMMUNICATION/INFORMATIONAL ITEMS

12.1. The Governing Board will be provided information on BUSD's District General Obligation (GO) Bond History and New GO Bond Program Analysis.

Rationale:

As the District approaches full expenditure of its locally-approved Measure S GO Bonds for BUSD School Facilities, and there remains school facility needs from the District's Facility Master Plan, the District is providing information on the District's GO Bond History and New GO Bond Program Analysis.

Minutes:

Mr. Tim Rahill, Chief Business Official introduced this item with a brief explanation of what it entailed along with an introduction of Mr. Jon Isom, BUSD's Financial Advisor to provide the presentation on it.

Questions/Statements from the board included the following:

Trustee Ferrucci expressed concern regarding the make-up of the community and the fact that many retirees on a fixed income as well as the timing for this to be considered because of being in a pandemic. Ending by stating that she will need to feel solid on the expenditures of the remaining monies in order to consider.

Mr. Isom explained that right now it is simply the idea of beginning the exploration process and putting out the survey for interest level within the community.

Trustee Grubbs asked a clarifying question in regards of it being a contingency exploration what the cost of this is to the District. She expressed she expressed that she was in agreement with Trustee Ferrucci's concerns. She also asked Mr. Rahill what the priorities would be and cost.

Dr. Young told the board the District would follow up with a board presentation of their concerns/request.

12.2. BUSD District-paid Benefits and Increase to School Board Stipend for School Board Members

Rationale:

Currently, a school board member may participate in the district benefit plans at his/her own expense, and is provided the statutorily-allowed school board stipend of \$240/month. It is at the school board's discretion to consider providing district-paid benefits and up to an annual 5% increase to the monthly school board stipend to its school board members. Staff will provide a presentation on the details regarding board benefits and stipend for possible action at the organizational meeting on December 9, 2021.

Minutes:

President Zada asked that at the December 9 meeting we act on just the 5% stipend increase and omit the Board benefit portion that was part of this item. She explained that after reviewing the cost of Board benefits she would prefer that money going back to the district. With that, President Zada invited Sue Wing, community member and Registrar at Benicia Middle School to provide a public comment on this item.

Ms. Wing expressed her support of the school board and her appreciation for pulling the benefit portion of it as it was the right thing to do.

13. NON-CONSENT ACTION ITEMS

13.1. Consideration and Approval of Resolution: "AUTHORIZING THE ISSUANCE AND SALE OF 2021 GENERAL OBLIGATION REFUNDING BONDS IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$9,000,000 TO REFINANCE OUTSTANDING BONDS OF THE DISTRICT, AND APPROVING RELATED DOCUMENTS AND ACTIONS"

Rationale:

The District wishes to initiate proceedings for the issuance of general obligation refunding bonds to refinance certain maturities of the District's outstanding General Obligation Bonds Election of 2014, Series A. The Resolution sets forth all of the terms and conditions of the issuance of refunding bonds to achieve interest rate savings. The Resolution authorizes the Bonds to be issued as traditional, federally taxable, general obligation bonds pursuant to the authority contained in the California Government Code, which will be payable from the receipts of ad valorem property taxes levied by the County on property within the District.

13.2. Consideration and Approval of the Declaration of Need for Fully Qualified Educators that was previously on the May 6, 2021 agenda under the Consent Calendar.

Rationale:

Each year prior to June 30, public school districts must file with the California Commission on Teacher Credentialing (CCTC) a declaration of need for fully qualified educators. The declaration provides the District's best current estimate of the number of emergency teaching permits and limited assignment permits it may need to appropriately staff its schools as well as local efforts it will undertake to certify, assign, and develop fully qualified certificated personnel for the pending school year. The signed, Board-approved declaration must be on file with the CCTC in advance in order for any emergency permits to be issued to certificated employees on the District's behalf. Action on this item was taken at the board meeting of May 6, 2021, however it was done under the Consent Calendar and the commission brought it to our attention that it must be acted on as a "Non-Consent" Action item; therefore, we are bringing it before the board once again to have it corrected. Thank you for your consideration.
