District Goal Alignment

Education Code Section 5019.5

- ▶ Education Code section 5019.5 requires that school districts with district-based elections review and, if necessary, update trustee areas every ten (10) years following the release of updated census information.
- ▶ Education Code section 5019.5 requires districts to complete this process by **March 1, 2022**.

Census Review

- ▶ The process of **reviewing** trustee areas is **different** than the process of **transitioning** to district-based elections
- ▶ For example, County Committee approval is **not required**, and there is **no requirement** to amend the City Charter

One Person, One Vote Standard


- ▶ Federal Law and the Equal Protection Clause **require** that each trustee area be roughly equal in population to ensure compliance with the “**one person, one vote**” standard
- ▶ Small deviations (**10% or less**) are presumptively constitutional where required to meet other criteria, such as preserving “**communities of interest**” and to prevent diluting the vote of a racial minority




Next Steps
