SUBJECT: COUNTY OF SANTA CLARA TREASURY INVESTMENT PORTFOLIO STATUS

### **RECOMMENDATION**

Receive and file the September 30, 2021 Detailed Investment Portfolio Listing.

### **DISCUSSION**

In compliance with the State of California Government Code as amended by Chapters 783 and 784, Statutes of 1995 and in compliance with County Policy, the Santa Clara County Treasury Investment Portfolio Report as of September 30, 2021 is submitted for your review and acceptance.

The attached detailed investment reports list each investment of the County Treasury Pool, as well as individual reports for specific investment funds that each school district or special district has in the County Treasury. The reports include the respective purchase and maturity dates, par value, amortized cost, market value, and yield to maturity for each investment.

A summary of market value versus cost is provided below for Commingled Investments of the County Pool.

The yield of the Pool on September 30, 2021 was .75%. As a comparison, on September 30, 2021 the yield of a 6-month Treasury Bill was .05%. A two-year Treasury Note was .28%. The State of California Local Agency Investment Fund (LAIF) yield was .21%.

Attached with the current investment strategy is a schedule that lists the average weighted maturities and yield for the Commingled Investment Pool. Charts outlining investment concentration and distribution of bond maturities are provided for the Pool. Also included is a chart showing the one-year history of the Pool along with interest rates offered by selected comparable instruments.

Securities are purchased with the expectation that they will generally be held to maturity, hence unrealized gains or losses are not reflected in the yield calculations.

The market values of Pool securities were taken from pricing services provided by Bank of New York Mellon, Bloomberg Analytics, dealer quotes, and an independent pricing service.

A combination of maturing securities, new revenues, and tax receipts will adequately cover the anticipated cash flow needs for the next six months. Cash flows are continually monitored and are considered paramount in the selection of securities purchased for the Pool.

### Economic Update and Portfolio Strategy

September 30, 2021

The pace of growth in the U.S. economy slowed markedly in the third quarter. Gross domestic product grew at an annual rate of 2 percent, the weakest quarter of growth since the recovery began. Despite strong consumer demand, the limited availability of a wide spectrum of goods and services due to supply chain disruptions and labor shortages restrained overall spending. The drop-off in spending is clearly illustrated by personal consumption which grew at just a 1.6 percent during the quarter after a rapid 12 percent pace in the prior period.

Most of the decline in real purchases occurred in the automobile sector. The reduction in sales of motor vehicles and parts alone took away 2.7 points off gross domestic product. This suggests that, absent the semi-conductor chip shortage that continues to plague the auto industry, the economy would have registered annual growth of 4.7 percent in the third quarter. This roughly approximates the pace of GDP earlier this year.

Even with weak third quarter performance, economic forecasters expect the post-pandemic recovery will continue and project 5.7 percent growth in real gross domestic product fueled by consumer spending for 2021. Producer inventories continued to fall, as they have all year, indicating that pent-up demand is accumulating among businesses as well as consumers. Because of lockdowns during which spending was curtailed and the unprecedented amount of stimulus money from the government in response to the pandemic, it is estimated that households have accumulated more than \$2.0 trillion in excess savings during the coronavirus crisis. Household wealth has been further bolstered by soaring stock and housing values.

Perhaps most importantly, wages, the most decisive factor affecting spending, rose strongly again in September as companies outside the most Covid-affected industries quickly hired available workers, at competitive wages. Compensation of employees at private businesses grew at a robust 9.2%, easily outpacing the rise in inflation. Of note, compensation is slightly above its pre-pandemic trend, a positive milestone.

Economists expect ongoing increases in demand as the economy re-opens. The Delta variant which led to a spike in coronavirus cases across much of the country has already begun to subside. With this most recent wave, leisure and hospitality businesses, a main driver of job growth earlier this year, was strongly impacted. As a consequence, employers added only 194,000 jobs in September, a reduction from the 366,000 added in August and far below than the one million job increase in July. Job growth in these sectors should improve.

Of note, household consumption of services continued to rebound, adding 3.6 points to real GDP for the quarter, compared to 2.1 and 5.4 respectively in the first two quarters of the year. The economy is continuing to rebalance from the lockdowns of last winter and spring, which caused a collapse in the service sector and concurrently triggered a massive surge in the consumption of goods.

U.S. inflation remained accelerated in September and was at its highest rate in over a decade. The personal consumption expenditures price index excluding food and energy costs, an inflation measure followed closely by Federal Reserve policy makers, remained elevated, growing an annualized 4.5 percent in the third quarter after posting a 6.1 percent jump in the prior three months. Although not comparable with inflation of the 1970's, this is a significant change after two decades in which consumer price inflation in the U.S. has been anchored well below 2 percent.

Unusually high demand is a crucial factor driving higher inflation. Spending accelerated over the first three quarters as more people received Covid-19 vaccinations, businesses reopened and trillions of dollars in federal aid circulated through the economy. The shipment of both inputs and finished goods remains a major problem for manufacturers. West Coasts ports have been hampered by record backlogs, trucking companies and railroads continue to face bottlenecks, and shipping container costs have surged. A shortage of workers is also driving up wages, putting pressure on companies to raise prices. A sharp upswing in restaurant prices during the past few months is a sign of this pass-through from wages into higher prices.

Higher inflation has already begun to weigh on Federal Reserve Bank (Fed) policy decisions. Policy makers have expressed concerns that labor shortages and disrupted supply chains were raising the risks of more persistent inflation. This view contrasts to earlier assumptions that supply demand imbalances would be temporary, a result of reopening the economy and would generally dissipate with time. Policy makers may be forced to address rising prices and other inflationary pressures with earlier-than-expected interest-rate hikes. Tightening monetary policy would pose a threat to an already fragile recovering economy and impact equity and property prices. Although the Fed is carefully monitoring the current inflation surge, it is widely expected that policy makers will continue to maintain, over the near term, their benchmark interest rate as unchanged in a range of 0 to 0.25 percent. Additionally, all evidence indicates that the Fed plans to conclude their bond-buying stimulus program by June 2022. The additional monetary stimulus is no longer needed given the progress made by the economy and labor markets so far. The Fed buys about \$120.0 billion of Treasury bonds and mortgage-backed securities every month. Purchases helped keep interest rates low by reducing the supply of outstanding securities.

The portfolio strategy continues to focus on the:

- (1) acquisition of high-quality issuers;
- (2) identifying and selecting bonds with attractive valuations;
- (3) appropriately sizing the liquidity portion of the portfolio to ensure adequate cash for near term obligations; and
- (4) ensuring that monies targeted for longer term investments are deployed in vehicles with favorable risk-adjusted yields.

### Portfolio Liquidity Adequacy, Review, and Monitoring

#### **Yield and Weighted Average Maturity**

The yield of the Commingled Pool is 0.75 and the weighted average life is 670 days.

#### **Liquidity Adequacy**

The County Treasurer believes the Commingled Pool contains sufficient cash flow from liquid and maturing securities, bank deposits and incoming cash to meet the next six months of expected expenditures.

#### **Review and Monitoring**

FHN Financial Main Street Advisors, the County's investment advisor, currently monitors the Treasury Department's investment activities.

#### **Additional Information**

Securities are purchased with the expectation that they will be held to maturity, so unrealized gains or losses are not reflected in the yield calculations.

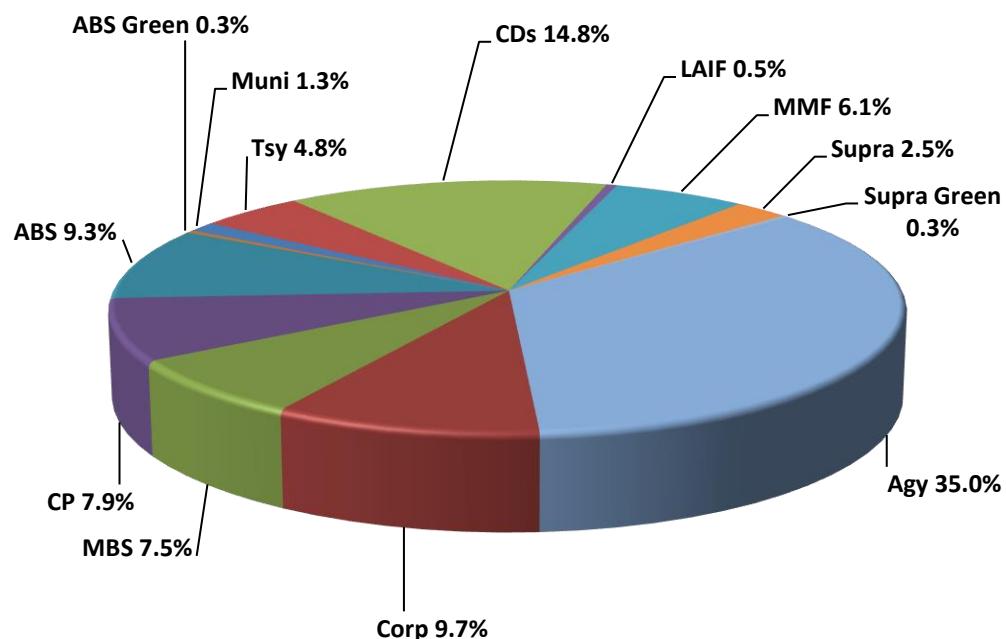

**September 30, 2021**



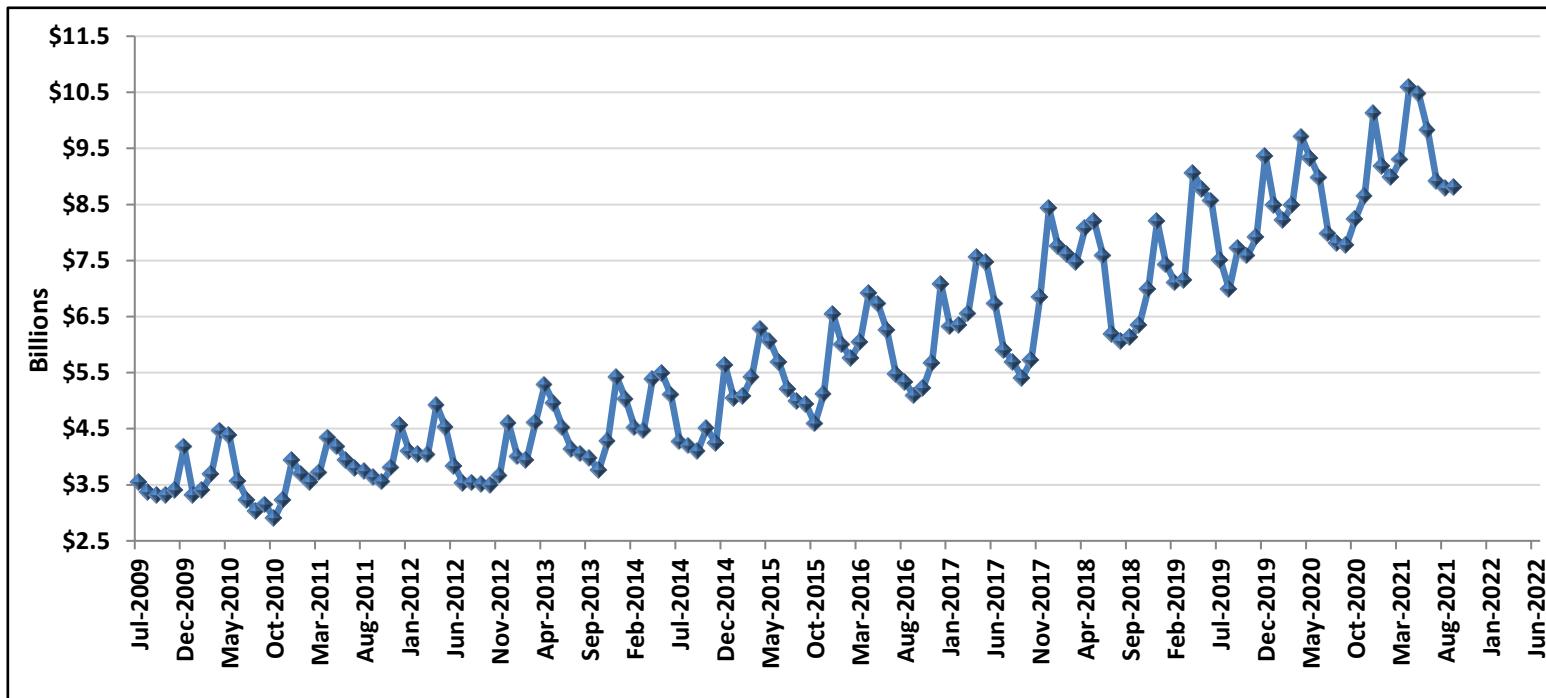

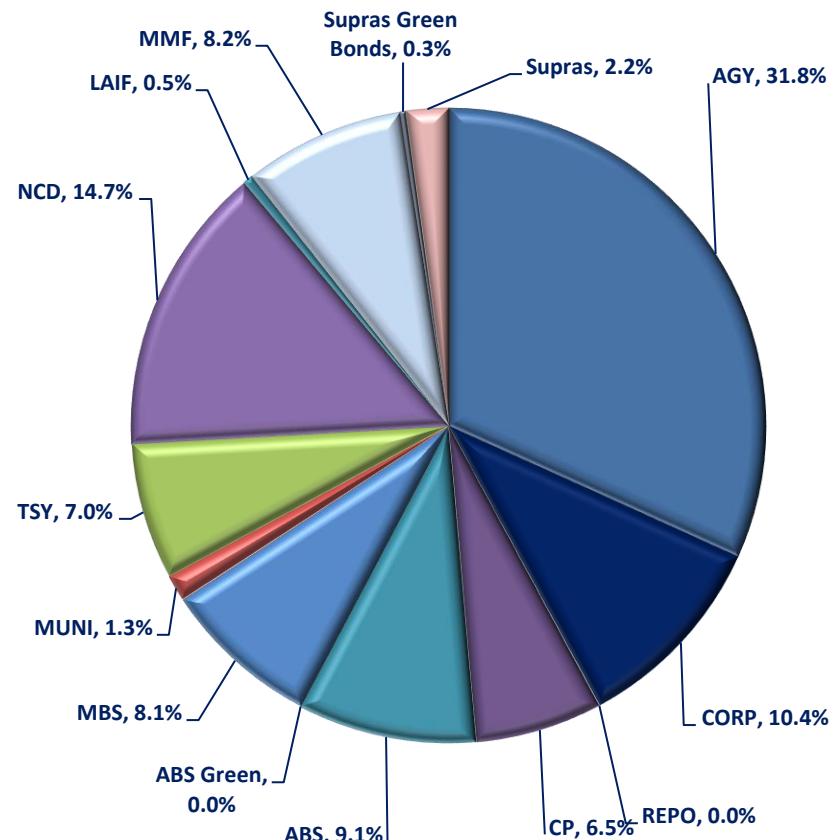
