School Facility Conditions and Planned Improvements (School Year 2021 - 2022)

Cosumnes Oaks High School opened in 2008. The school has seventy classrooms, twelve science rooms, a career center, and a full stadium and track facility. The school has a commercially-fitted Culinary Arts building, 700-seat Performing Arts Theater, as well as a 280-seat Black Box Theater. The school also has a Medical Careers building, and simulation clinic room for the Medical Careers Pathway. The school shares a 12,000 square foot library with Elizabeth Pinkerton Middle School. There are two gymnasiums, a band and choir room, and a broadcasting studio.

The LEA takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the LEA uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the district office. Included is information from the facility survey instrument on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment. Our school received an "Exemplary" status based on the State's definitions for each of the eight categories evaluated, which is the highest rating possible.

The district's maintenance and grounds departments work in concert with the school site custodial team to ensure that school buildings, classrooms, and grounds are maintained at exceptional levels to provide a safe and functional environment for all students. The district utilizes the latest electronic work order system enabling site administration and custodians to communicate maintenance needs, urgent repairs, or necessary projects. Emergency repair needs are immediately resolved by either the school custodian or district maintenance staff. The school's custodians work as a team and with the principal to develop a daily cleaning process and schedule. Each morning the custodian inspects the school prior to students and staff entering school grounds. Restrooms are inspected throughout the day to ensure that they are adequately stocked, safe, and sanitary. The Board of Education has adopted cleaning standards for all schools in the district. A summary of these standards is available at the school office, or at the district office.

The State Deferred Maintenance Program (DMP) was established in 1980 to aid districts in major maintenance projects. Beginning with the 2013-2014 fiscal year and the inception of the Local Control Funding Formula (LCFF) the State has intended for Deferred Maintenance needs and expenses to be included in the District's LCFF allotment. The district continues to fund routine projects previously considered as part of the State's former DMP at levels required by the State and continues to use local resources.

Recent Modifications have been completed for the following classrooms with the support of grant funding: Broadcast Studio upgrade, worker space for the Robotics Pathway, remodel of the Graphic Arts classroom to include technology. An additional two classrooms for the medical pathway as well as a simulated clinic room.

Career Technical Education Programs (School Year 2021 - 2022)

Career Technical Education (CTE) provides opportunities for COHS students to prepare for college, career and life through a Linked Learning approach that integrates rigorous academics, technical skills, relevant real-world experiences, work-based learning opportunities, and wrap-around support to help students develop the 21st-century skills and habits of mind they will need to succeed after graduation. Guidance and career counselors offer support focused on achieving the outcomes described in the EGUSD Graduate Profile. COHS provided the Get Focused...Stay Focused anchor class for all 9th-grade students. Each student creates a 10-year plan that focuses on college, career, and beyond. COHS offers the following CTE programs that promote leadership, develop job-related skills, offer work-based learning opportunities, and increase interest in school: California Partnership Academies (CPA), High Quality Career Pathways (HQCP), and Explore CTE Programs. CPAs feature cohort scheduling in CTE and academic core classes, integrated projects, and work-based learning opportunities. HQCPs provide a two-to-three year sequence of CTE courses within a career pathway. Pathway programs offer work-based learning opportunities and industry-recognized certification when available. Explore CTE programs, open to students across the district, allow students to complete an intensive training course in one year or less, take courses leading to industry certification, or experience internships. All CTE programs have an advisory committee that includes industry representatives for guidance and input. CTE programs at COHS also allow students to meet graduation and A-G requirements. In 2021-22, COHS offered one CPA, the Culinary Arts Academy. HQCPs at COHS include Architectural Design and Engineering, Digital Communications, Broadcast Journalism, Explore CTE Culinary Arts, Robotics and Programming, and Medical Careers. EGUSD's Department of College and Career Connections supports COHS's CTE programs through strategic planning, oversight, and professional development. Individual student assessment of work readiness skills in CTE programs takes place through end-of-course exams, projects, portfolios and defense of learning, industry certifications, or other means. Our CTE programs are evaluated through multiple measures: the number of students completing a CTE pathway, graduation rates, A-G completion rates, GPA, and attendance. Our CTE teams complete a rigorous self-reflection process, followed by district certification. The district collects data regarding continued education and employment from students one year after graduation as part of the Carl D. Perkins reporting process.

COHS has six counselors, resource specialists, psychologist, speech therapist, health technician, librarian, and a school resource officer. ELA and Math curriculum coaches support our faculty. COHS has Tier I and II PBIS provides support for students. COHS offers AVID classes at each grade level. Freshmen are enrolled in Focus on College and Career. Academies/Pathways include: VAPA , Architectural Design and Engineering, Broadcast Journalism, Graphic Arts, Robotics, Culinary Arts, AP Capstone, and Medical Careers. Advocacy is held once per week for every grade level. COHS also offers twenty-one College Board approved Advanced Placement courses. A partnership with the Los Rios Community College District provides students with the opportunity to earn up transferrable college credits by completing college courses.

Teachers and staff are dedicated to improving their skills to meet the needs of our students. Cosumnes Oaks High School received a six year accreditation from the Western Association of Schools and Colleges in 2017-2018. There are at least three late start meeting dates per month devoted to Professional Learning Communities. A majority of staff meetings include 80% professional development. A few are as follows: Equity and Implicit Bias, Suicide Awareness, Mandated Reporter, Constructive EL Student Interaction, Positive Behavior Intervention & Supports, Restorative Practices, and Norming Student Behavior Referrals.
