3. INFORMATION/STUDY

3.1 California Voting Rights Act (CVRA) Map Consideration Public Hearing #1

The Galt Joint Union High School District's Board of Education is currently elected under an "at-large" election system, where Board members are elected by voters of the entire District. Cities, public entities and other school districts have recently had their at-large election systems challenged under the California Voting Rights Act (CVRA). On April 14, 2020, the Board adopted Resolution No. 1920-14, signaling its intent to transition to by-trustee area

elections upon the release of the 2020 Federal Census data. In a by-trustee area election system, each Board member must reside within the designated trustee area boundary and is elected only by the voters in that trustee area. With the recent release of the 2020 Census data, the Board is set to begin the process to adopt by-trustee area elections.
