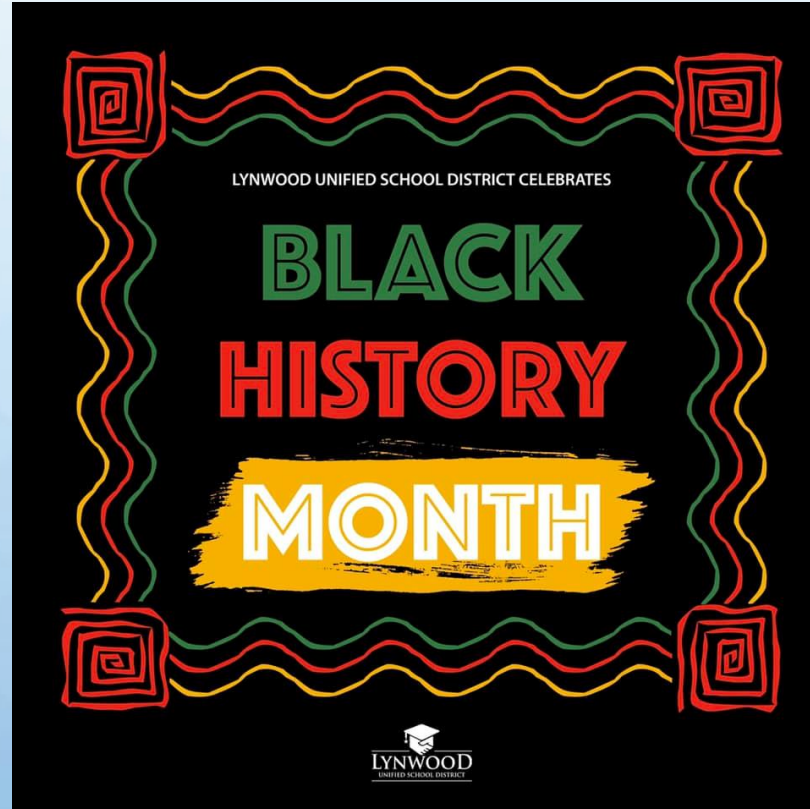

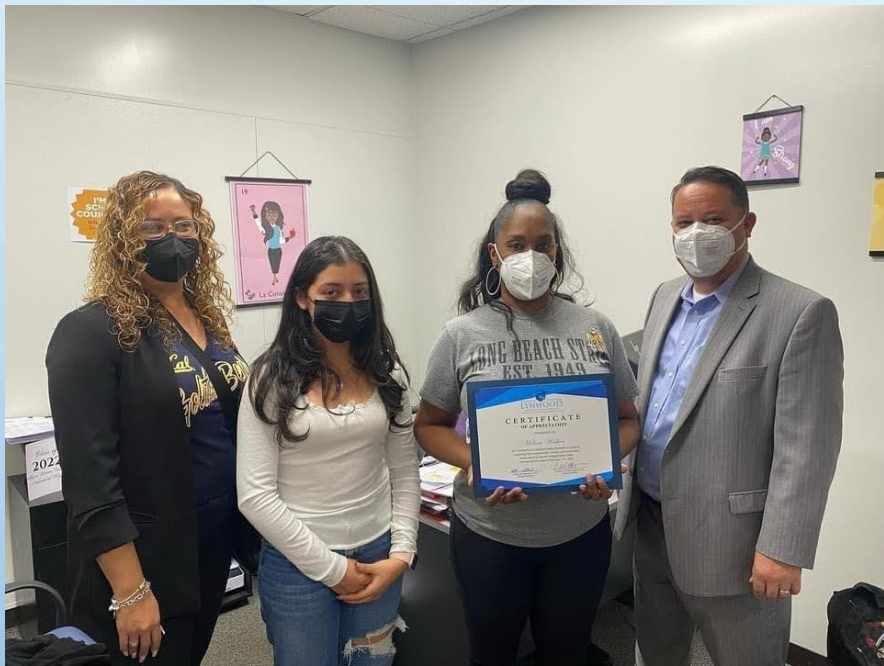

Dear Chairs McCarty and Laird:

On behalf of the Lynwood Unified School District, I am writing to support many aspects of the proposed 2022-23 State Budget for transitional kindergarten (TK)-12 education.

Lynwood Unified appreciates the acknowledgement that districts statewide are facing significant enrollment declines. We support the inclusion of more than \$1 billion to address this issue for districts.

While the estimated 5.33% cost-of-living adjustment (COLA) is a significant increase, it merely keeps up with historic levels of inflation and pension increases all districts are experiencing. Since the beginning of the Local Control Funding Formula (LCFF), CSFC has advocated for more adequate funding for core education, which is why we are calling on the Administration and Legislature to provide more than \$4 billion in ongoing LCFF funding in 2022-23 above the statutory COLA.

We support core educational investments in ongoing special education programs, bringing per average daily attendance funding to \$820, demonstrating the state's commitment to students with disabilities as this student population and their needs continue to grow. Additionally, we support the \$500 million investment in inclusive early education infrastructure and other one-time investments like new construction, modernization, kitchen facilities, and transportation all support core TK-12 education.

With the state's funding surplus, we call for an additional infusion of resources into CalSTRS and CalPERS on behalf of school employers. The state is making this wise investment of resources to pay down its future obligations and we respectfully request the same.
