Resolution No. 21-22/41

*Resolution to Decrease the Number of Certificated Employees
Due to a Reduction or Elimination of Particular Kinds of Services*

WHEREAS, Education Code sections 44949 and 44955 permit the Governing Board to reduce or discontinue particular kinds of programs and services not later than the beginning of the following school year; and

WHEREAS, the Governing Board of the Lynwood Unified School District ("District") has determined that it shall be necessary to reduce or discontinue the particular kinds of services of the District described herein no later than the beginning of the 2022-2023 school year; and

WHEREAS, it shall be necessary at the end of the 2021 - 2022 school year to terminate the employment of certain certificated employees of the District as a result of this reduction or discontinuance in particular kinds of services; and

WHEREAS, applicable law requires that no less senior employee shall be retained to render service for which an employee who is not to be retained is credentialed and competent to render, unless the less senior employee possesses competency in those areas of service in which the Board has determined to reduce program; and

WHEREAS, it is the opinion of the Board that it is in the best interest of the District to reduce the number of regular certificated employees of the District as hereinafter set forth;

NOW, THEREFORE, BE IT RESOLVED by the Governing Board of the Lynwood Unified School District as follows:

- A. That the foregoing recitals are true and incorporated herein by this reference.
- B. That the following particular kinds of services be reduced or eliminated as indicated commencing with the 2021 school year:

PARTICULAR KINDS OF SERVICE	FTE
Early Childhood Education Teachers	12.0
Early Childhood Education Facilitator	2.0
Total Full Time Equivalent Reduction:	14.0 FTE

- C. That due to the reduction or elimination of particular kinds of services the number of certificated employees of the District be terminated pursuant to Education Code section 44955.
- D. That the District Superintendent or designee is directed to send appropriate notices to all employees whose services shall be terminated by virtue of this action pursuant to Education Code sections 44955 and 44949.
- E. Nothing herein shall be deemed to confer any status or rights upon any temporary or categorically funded project certificated employees in addition to those specifically granted to them by statute.
