6. SUPERINTENDENT SERVICES/BOARD

6.1. Strategic Plan Goal Setting Process

Sepideh Yeoh, CSBA Educator / Consultant made a presentation regarding the Strategic Plan Goal for the District. She presented a video to the Board and asked for their reflection and reaction to the video. All members from the board made comments about the video and reflected on the importance of teamwork, being calm, being kind and the power of culture.

Mrs. Yeoh also presented the Board with a working styles questionnaire and working styles scoring grid to identify their working styles.

Superintendent Ochoa made a presentation regarding data for ELA and Mathematics for second language students in the District and compared the results of the data among the schools in the District and pointed out that the data varies and different strategies will be used depending on the data.

Board Comments:

Trustee Warren made a comment about the data and suggested addressing all students.

Trustee Chin indicated that he is very excited about the data and felt that a lot of the students were affected by the pandemic and the way they were taught.

Trustee Corzo expressed that it is sad to see this data but she is grateful that we need to do things differently and that it is important to recognize that. Trustee Corzo added that the work being done will benefit all kids.

Trustee Watkins made a comment and expressed that it is important that we are very explicit in order to guide decision making and goal setting at the board and district level.

Trustee Proctor made a comment about the data shared by Superintendent Ochoa and liked the way the data was presented and indicated that now we know that when we look at the California dashboard there is more to it and that this is not what we want and changes will be made.

All Board Members analyzed data and collaboratively brainstormed and crafted the following draft goals language for the District.

1. Implement district policies and practices to reduce inequitable outcomes for ALL students and staff by prioritizing equity access and inclusion.
2. Provide a safe, care, nurturing and culturally responsive environment for all students to meet the needs of the whole child.

3. Ensure learning and achievement for ALL Pre K through 8th grade students resulting in closing the achievement gap and culminating in personal and academic success in high school and beyond.

Mrs. Yeoh recapped the highlights of the Workshop and led the team in discussing next steps.
