

**RESOLUTION NO: 21-21/22**

**RESOLUTION OF THE BOARD OF EDUCATION  
OF THE SAN MATEO-FOSTER CITY SCHOOL DISTRICT  
APPROVING ADJUSTED TRUSTEE AREA BOUNDARIES**

WHEREAS, The San Mateo-Foster City School District (“District”) currently uses a by-trustee area election process to elect its governing board members; and

WHEREAS, Education Code section 5019.5 requires school districts that elect by-trustee area to adjust the trustee area boundaries following each decennial federal census using population figures validated by the Population Research Unit of the Department of Finance; and

WHEREAS, the adjustments shall ensure that the population of each trustee area is proportional pursuant to Education Code section 5019.5(a)(1) or (2); and

WHEREAS, District staff, consultant and legal counsel have prepared a draft adjusted trustee area boundary plans for the District’s consideration (the “Plans”) that the Board has considered; and

WHEREAS, the Board conducted public hearings on February 10, 2022 and February 24, 2022, to receive public input and comment on the Plans; and

WHEREAS, the Board has considered all such public input and comment on the Plans; and

WHEREAS, the Board desires to adopt Plan (scenario) # \_\_\_\_ for use effective the November, 2022 general election and thereafter until further adjusted by the Board.

WHEREAS, related to trustee area boundary adjustments pursuant to Education Code section 5019.5 following the release of the decennial federal census, the District will hold by-trustee area elections in two areas (areas \_\_ and \_\_) at its November 2022 election. The District will hold by-trustee area elections in three areas (areas \_\_\_\_, \_\_\_\_, and \_\_\_\_ ) at its November 2024 election.

NOW THEREFORE, be it resolved by the Board of Education of the San Mateo-Foster City School District as follows:

1. That the above recitals are true and correct.
2. That the Board hereby adopts the Plan.
3. That the Superintendent and/or her designee take all actions necessary to implement the Plan in time for the next governing board member election in November of 2022.
