- I. The "Scope of Services" of the above referenced Agreement is hereby modified as follows:
(For "Scope of Additional Services" refer to the Exhibit A (LPA Inc.s' Proposal), which is for reference only):
- A. Additional Services Proposal 1, \$566,322.00 Fee adjustment for the Construction Cost Budget and Scope at end of Design Development
- II. "Compensation and Payment" of our Agreement approved by the Board April 15, 2021 of \$541,100.00 is hereby modified to allow for the additional fees required to implement the above changes. The present fee for architectural services of **\$541,100.00** is hereby increased by a not-to-exceed fee of **\$566,322.00**, for a fee of **\$1,107,422.00** for the architectural services. Once all bid packages have been awarded, District and Consultant will meet to review costs compared to the Design Development estimate. The Consultant's fee may be revised if there is a difference between the two costs.

The new contract amount is **\$1,107,422.00**.

All other conditions of our Agreement (and subsequent Amendment(s) set forth above) remain in full force and effect as originally stated.

As we have discussed, the project to add a MPR building at the Highlands campus included location with site team input requiring regrading, retaining work and relocation of a play structure. At this point in time, LPA is requesting an adjustment to our base contract to include the site siting specifics for this addition of the MPR to the campus.

Since discussing the site location, SM-FC has requested a proposal for synthetic turf and full execution of solar ready work on the campus. Per our discussions, the following is an additional service request based on our conversations, our current understanding of the services requested, and direction provided by the District.

Upon your review and execution of the additional services agreement LPA will incorporate the inclusions into the same DSA deadline as the primary MPR project. Each of these additional scopes of work will be included in one DSA submittal package without increment or phasing.
