## Addendum to Agreement

This Addendum, hereinafter referred to as the “ADDENDUM” is made and entered by and between Desert Sands Unified School District, hereinafter referred to as “DISTRICT”, and Desert Occupational Therapy for Kids, Inc., hereinafter referred to as “CONTRACTOR”. DISTRICT or CONTRACTOR may sometimes be referred to hereinafter individually as “Party” or be collectively referred to as “Parties”.

### RECITALS

**WHEREAS**, the Parties entered into a certain Agreement dated effective June 8, 2021, hereinafter referred to as the “AGREEMENT” and was created in DISTRICT’s accounting system as Contract C-4618; and

**WHEREAS**, the Parties agreed to the scope of Services in Paragraph 1 of the AGREEMENT, hereinafter referred to as the “SERVICES”; and

**WHEREAS**, DISTRICT now desires to request additional SERVICES; and

**WHEREAS**, CONTRACTOR has the resources and abilities to perform these SERVICES.

**NOW, THEREFORE**, the Parties, mutually agree to enter into this ADDENDUM subject to the following terms and conditions.

DISTRICT agrees to continue to pay CONTRACTOR for SERVICES satisfactorily rendered pursuant to paragraph 4 of the AGREEMENT. At the time of the execution of this ADDENDUM, DISTRICT is in need of additional SERVICES of up to one hundred and eighty-five thousand dollars, (\$185,000), bringing the total AGREEMENT contracted amount to a maximum of six hundred and sixty thousand dollars, (\$660,000).

The Parties agree that either Party may request to amend this ADDENDUM at any time by submitting a written request in accordance with the conditions stated in Paragraph 23 of the AGREEMENT.

All other terms and conditions of the AGREEMENT remain in full force and effect and shall not be affected, impaired or invalidated by the signing and execution of this ADDENDUM. If there is any term, condition, or provision of this ADDENDUM that is held, in whole or in part to be deemed invalid, void or unenforceable, the ADDENDUM shall be deemed null and void and the AGREEMENT shall remain in full force and effect.

The ADDENDUM is hereby entered into as of the 16th day of March 2022.
