## SERVICES ACCEPTANCE MEMORANDUM OF UNDERSTANDING

NOW, THEREFORE, in consideration of the recitals and mutual obligations of the parties herein expressed, The Parent Institute for Quality Education (PIQE) and Benjamin Franklin Elementary School agree as follows:

### RECITALS

- A. Scope of Services: PIQE will provide its Social Emotional Learning Program for the parents/guardians of the students enrolled in the school above mentioned. PIQE will recruit parents by phone, provide an Orientation session, a series of seven weekly training sessions, organize and conduct a Q&A forum with the school's leadership team, culminating in a graduation ceremony with certificates provided to parents who attend four or more sessions. The program is designed to develop skills and techniques which will empower parents to address the educational needs of their school-aged children.

- C. Virtual Services: In response to the pandemic impact on COVID-19 and Delta variant safety measures, should it be deemed necessary, PIQE is prepared to provide on-line services. For virtual services, PIQE's Signature program will be provided in "eight sessions/seventy minutes each, in which PIQE will support families with online connectivity and navigation, bridge families to resources, and helping families to understand, to re-engage virtually and in-person with teachers and schools.
- D. Location: Benjamin Franklin Elementary School of the Desert Sands Unified School District
- E. Session Dates: April 14<sup>th</sup> through June 9, 2022

Compensation: A flat fee of \$9,500 for two classes, at one site with no more than 20-25 parents in a class; and an additional flat fee of \$2,000 for any additional class that opens in any language (up to 15) at the same school, same site. **PIQE will provide a Data Analysis for the school mentioned above.**


