SCOPE OF WORK

Maintenance shall consist of:

1. Inspection of system components every three months. (See Inspection - *Mechanical*)
2. Physical adjustment of components needing attention.
3. Recommendation of replacement or repair of parts as needed, including preventative maintenance.
4. Recommendations for, and monitoring of periodic pumping of accumulated solids.
5. Remote telemetry monitoring of system.

Inspection *Mechanical*

Septic Tanks Inspect all risers in the primary and secondary side of each septic tank. Inspection shall include but not be limited to:

- Water Levels
- Sludge thickness and consistency
- Plumbing Tee's cleared of obstacles

Recirculation Pump Check for proper performance including liquid levels, pump floats, pump amperage, flow rate and water level. Clearance of any obstructions.

Textile Filter Pods

- Inspect emitters
- Inspect textile filter (clean if necessary)
- Inspect recirculation system for proper performance

Calibrate Telemetry Visually inspect and calibrate all sensors and controls to assure proper performance and reporting.

SCOPE OF WORK - *Other*

- AX Max treatment tank inspection
- Check and document levels of treated effluent in seepage pits
- Excludes pumping of septic tank , as needed
- Provide documentation of metering

Annual Maintenance Cost (Invoices will be sent quarterly and due upon receipt. A finance charge of 1.5 is applied after 30 days) - This maintenance agreement covers "Preventative Maintenance" only. Any and all other services and materials needed will be billed on a time and material basis at the current service rates.
