Siskiyou Union High School District (SUHSD) has a need for special services of which the Independent Contractor named below (here-in-after referred to as the "Contractor") is specially trained, experienced, and competent to perform such special service.

Scope of Services: School-Based Therapy and Behavioral Support. Specific services may include individual therapy, group therapy, family therapy, classroom lessons, behavioral modification/management, parent education, I.E.P. attendance, special event participation, and other services deemed appropriate and approved by SUHSD Superintendent.

The parties mutually agree to duties as follows:

### SUHSD Duties

1. SUHSD will provide technical assistance in the development of policies and procedures consistent with those of SUHSD. Components may include referrals, tracking, reporting, invoicing, regulation updates, etc.
2. SUHSD will afford the school staff the opportunity to collaborate with the Contractor as needed to review on-going service needs.
3. SUHSD will observe and respect the aspects of confidentiality that ensure student privacy and foster an effective student/therapist relationship.

### Contractor Duties

1. Contractor will provide services within the scope of his training, licensing, and certification.
2. Contractor will work collaboratively with school staff to create and implement service policies and procedures consistent with those of SUHSD.
3. Contractor will maintain consistent communication with school staff in order to ensure service quality and effectiveness.
4. Contractor will observe Confidentiality and Privacy practices in accordance with the regulations of his license and certification. Contractor will educate and inform school staff, students and parents of these practices as needed.

5. Contractor will provide timely and accurate invoice documentation in accordance with school requirements.
6. Contractor will provide the school district with required information and documentation needed to provide on-site school services (i.e. copy of license/certification, copy of liability insurance, copy of First Aid/CPR card, etc.).

### **Compensation and Billing**

Siskiyou Union High School District shall pay Contractor as a compensation for all services performed by Contractor pursuant to this contract where services begin in August, 2022 and end in August, 2023 as follows:

**\$100 per hour. This contract will not exceed \$3,000 per calendar year.**

It is agreed that said sums may be exceeded only upon the written consent of the Siskiyou Union High School District Superintendent or an appropriately assigned administrator.

It is agreed upon that this contract may be immediately terminated upon the discretion of either Siskiyou Union High School District or Jeremy Tacbas.
