9. INTERIM SUPERINTENDENT'S REPORT

Cheryl Jordan invited recent appointees, Jennifer Hutchison and Raquel Kusonoki, to say a few words. Both thanked the Board, Mrs. Jordan, mentors and co-workers for their support through the years.

10. REPORTS

A. NAMING OF SCHOOL FACILITIES

As the District moves towards closing escrow with the City of Milpitas for the McCandless property, Cheryl Jordan asked the Board for direction on how to go about naming the new school on McCandless Drive and other district properties that it wishes to name. She shared Board Policy 7310 *Naming of Facilities* which describes the process by which the Board can gather input from the community as well as the parameters for naming buildings, property, and facilities owned by the District.

Board members shared their thoughts on what the process should involve. Board members wanted to see a new naming committee, membership of which should include students and past teachers, principals and community members who have historical perspectives of the site locations who could suggest appropriate names. They would like to see a naming timeline for the football fields at MHS, the new Joint Use Facility on Escuela Parkway, and the new School on McCandless Drive.

B. OVERVIEW OF THE 2015-16 CALIFORNIA ASSESSMENT OF STUDENT PERFORMANCE AND PROGRESS (CAASPP)

The spring of 2016 marked the second year of operational testing of the online Smarter Balanced Summative Assessments. The California Department of Education has released these assessment results administered to all 3rd-8th and 11th grade students in English Language Arts/Literacy and Mathematics. The reports are posted on the CDE website, with information on public schools and districts in California.

These new assessment results serve to gauge academic growth and students' progress in learning new, more rigorous academic standards in comparison to last year's baseline.

Assistant Superintendent Norma Rodriguez provided the Board with an overview of the results and provided the Board an opportunity to ask questions.

11. ACTION/DISCUSSION ITEMS

A. RESOLUTION 2017.16 SUPPORTING MEASURE K

The City of Milpitas passed Resolution 8575, a resolution submitting to the voters of the City of Milpitas a Measure (Measure K) on the November 8, 2016 ballot to protect park and open space lands within its boundaries. The Measure, if passed by the voters, would amend the City of Milpitas General Plan to require voter approval to mandate that any attempt to rezone parks, parklands or open space to residential, commercial, or industrial or any proposal for residential, commercial or industrial development on parks, parkland or open space, must be placed before Milpitas voters and secure 2/3rds support.

The Board, at the last meeting, indicated that it would be willing to consider a resolution supporting Measure K.

Community members Harriett McGuire, Steve Munzel, Rohit Sharma, Matt Tiernan, and Pete McHugh, spoke in support of Measure K on the November 8, 2016 ballot and asked the Board to support this initiative.

B. PROCLAMATION RECOGNIZING THE CONTRIBUTIONS OF CONFUCIUS
