Memorandum of Understanding

For the summer 2017, the Milpitas Unified School District and the Milpitas Unified School District's Adult Education Programs agree to the following contracted services:

Adult Education will:

- 1. Provide the district a Summer Enrichment Program for grades 1-8 this summer. The program will run one twelve (12) and one thirteen (13) day sessions beginning June 12 and ending July 21, 2017.
- 2. Provide registration and payment intake at the rate of \$280 per twelve (12) days for the morning session 1. Provide registration and payment intake at the rate of \$560 per twelve (12) days for the all-day session 1. Provide registration and payment intake at the rate of \$280 per twelve (12) days for the afternoon session 1. Provide an hour of extended care at the rate \$90 per twelve (12) days per session 1. Provide registration and payment intake at the rate of \$305 per thirteen (13) days for the morning session 2. Provide registration and payment intake at the rate of \$610 per thirteen (13) days for the all-day session 2. Provide registration and payment intake at the rate of \$610 per thirteen (13) days for the all-day session 2. Provide registration and payment intake at the rate of \$610 per thirteen (13) days for the afternoon session 2. Provide registration and payment intake at the rate of \$610 per thirteen (13) days for the all-day session 2. Provide registration and payment intake at the rate of \$305 per thirteen (13) days for the afternoon session 2. Provide registration and payment intake at the rate of \$250 per thirteen (13) days for the afternoon session 2. Provide an hour of extended care at the rate \$100 per thirteen (13) days per session 2. For those not enrolled in the after school extended care option, a \$10 fee will be charged for pickups between 4 5 pm. Pickups after 5 pm will be charged at the rate of \$25 per 15 mins. Funds will be deposited in a district account managed by Milpitas Adult Education Program.
- 3. Monitor attendance, notify parents when needed and provide pay for teachers, babysitters and a secretary. Teachers will be placed on the Milpitas Adult Education salary schedule. Placement on salary schedule to be based upon years of experience, credits and degrees as determined by Milpitas Adult Education Program.
- 4. Hire the teachers, monitor classroom instruction, maintain student discipline and process time sheets to ensure accuracy.
- 5. Maintain financial records of expenses, tuition and fees, copying, and staff hours for audit purpose.

Milpitas Unified School District Business Department will:

- Set up fiscal records/account for intake and expenditure of funds. Tuition is set at the rate of \$280 per twelve (12) days morning session 1, \$560 per twelve (12) days all-day session 1, and \$280 per twelve (12) days afternoon session 1. Set up fiscal records/account for intake and expenditure of funds. Tuition is set at the rate of \$305 per thirteen (13) days morning session, \$610 per thirteen (13) days all-day session 2, and \$305 per thirteen (13) days afternoon session 2. Payments will be received through Milpitas Adult Education online registration system.
- 2. Handle all communications regarding these funds by the Milpitas Adult Education Program.
