O.II. Public Hearing on Local Control Accountability Plan (LCAP) for 2015-2018

Ms. Liann Reyes gave a presentation on the 2015-16 adopted budget. She gave an overview of the 2015-16 and stated that she uses the "Common Message" in the May revise. She reminded the Board that the budget is all projections and are assumptions. She explained the LCFF

numbers and gave some examples. She went over the staffing assumptions. The unaudited actuals are presented in September. She also went over the end fund balance and gave a brief explanation. She went over the multi-year projections and explained the 3% reserve. She added that the District would have to have money for unforeseen expenses.

She noted that the next steps is the state Deadline on June 15th and the District has 45 days to make adjustments. She went over the financial changes from the May revise.
