

AGREEMENT FOR SERVICES

Between

JARVIS ENGINEERING CO., INC.

And

SCOTTS VALLEY UNIFIED SCHOOL DISTRICT

For Fiscal Year, July 2017 – June 30, 2018

Scope of Work:

Jarvis Engineering CO., Inc. will provide services to Scotts Valley Unified School District which may include any of the following:

Work with the District, the Division of the State Architect (DSA) and other agencies and vendors to maintain DSA compliance for all schools. Identify the scope of any compliance issues, develop plans for maintaining compliance if required, complete documentation that is under the District's control and identify other resources required to maintain compliance.

Supervise major repair, construction and modernization projects, assisting in the implementation of systems and processes that ensure that all major projects are well documented. Recommend and prioritize projects that improve student health and safety and enhance learning.

Oversee the performance of the Supervisor in training for Maintenance & Operations (M&O), to improve and maintain the condition of the facilities and grounds, manage the computer-based work order system, ensure that all schools comply with all facilities-related health and safety regulations, oversee custodial standards, and establish or maintain practices, processes and systems that improve the performance and productivity of M&O. Work to maintain employee satisfaction and retain employees.

Project Timeframe and Term of Agreement:

Upon agreement by Scotts Valley Unified School District, Jarvis Engineering CO., Inc. will begin work described in this agreement on July 1, 2017. This agreement will expire on June 30, 2018 unless renewed or terminated by either party. Early termination will require one month's written notice by the party terminating the contract.

Principals and Contacts:

Michael Smith will be providing facilities and construction oversight services. The Superintendent and CBO will oversee this agreement for Scotts Valley Unified School District. Invoices for payment will be sent to the attention of the CBO for approval and payment by the District.

Scotts Valley Unified School District will be billed at an hourly rate of \$81.90, for up to 750 hours per year, unless it is mutually agreed upon to add hours based on district needs. Summer projects will be a priority. Supplies and materials will be purchased directly by Scotts Valley Unified School District through its routine purchasing process; however, small incidental supplies or parts may be reimbursed and invoiced separately from time, and this may not exceed \$1,000 per month.
