# 2<sup>nd</sup> ADDENDUM TO THE AGREEMENT FOR SECURITY SERVICES

Security service addendum is made this 28<sup>th</sup> day of June, 2017 to the original Agreement for Security Services dated June 24, 2015 between **Milpitas Unified School District**, whose address is 1331 E. Calaveras Blvd., Milpitas, California 95035, Santa Clara County, hereinafter called the "District" and **Admiral Security Services**, whose address is 2151 Salvio St., Suite 260, Concord, California 94520, hereinafter called the "Contractor."

### Article 3. Hourly Rate:

In exchange for the services provided, the District shall make payment to the Contractor at the following rate(s) per hour:

- A. 2017-18 School Year Security Guard Services for Milpitas High School, for approximately 2,654 hours @ \$26.88/hour or \$71,339.52. See Exhibit A.
- B. 2017-18 School Year Guard Services for additional events; may include but not limited to dances, graduation, athletics, use of facilities, and additional day time security when needed throughout the district @ \$24.49/hour. Time & a half if on a federal holiday
- C. 2016-17 School Year District-Wide Security Patrol Services during vacation periods @ \$28.06 per guard hour.
- D. 2016-17 School Year District-Wide Security Patrol Services during federal holidays @ \$42.09 per guard hour

### Article 4. Contract Period:

The duration of this Agreement shall be for a period of five (5) months, commencing **August 1, 2017, through December 31, 2017**. Prices shall remain in force during the initial term of this Agreement.

All other provisions and conditions of the original agreement remain the same except as amended in Exhibit A.
